NOTICE OF REGISTRATION CITY OF MOUNT PEARL

MUNICIPAL PLAN AMENDMENT NO. 62, 2006 & DEVELOPMENT REGULATIONS AMENDMENT NO. 162, 2006 & DEVELOPMENT REGULATIONS AMENDMENT NO. 165, 2006

TAKE NOTICE that the City of Mount Pearl Municipal Plan Amendment Number 62, 2006 and Development Regulations Amendment Number 162, 2006, adopted by Council on the 2nd day of May, 2006, and approved on the 11th day of July, 2006, has been registered by the Minister of Municipal Affairs.

In general terms, the purpose of Municipal Plan Amendment Number 62, 2006 is to add a general land use policy regarding landscaping requirements in the City. This policy would enable Council to provide a framework for the regulation of landscaping in the Development Regulations. In general terms, the purpose of Development Regulations Amendment Number 162, 2006 is to add a new section to the general development standards, Part II Section 40 of the Development Regulations, regarding landscaping to coincide with the Municipal Plan policy.

These amendments would provide Council with the authority to enhance landscaping requirements throughout the City.

TAKE NOTICE that the City of Mount Pearl Development Regulations Amendment Number 165, 2006, adopted by Council on the 2nd day of May, 2006, has been registered by the Minister of Municipal and Provincial Affairs.

In general terms, the purpose of Development Regulations Amendment Number 165, 2006 is to clarify the height of accessory buildings in residential use zones. The amendment to the Development Regulations modifies the conditions pertaining to the height of accessory buildings in all residential land use tables in Schedule C of the Development Regulations. The height restriction is modified to permit a slightly higher structure (a maximum height of 4.5 m measured from the floor level to the roof ridge), and additional conditions are added.

The Mount Pearl Municipal Plan Amendment Number 62, 2006, Development Regulations Amendment Number 162, 2006, and Development Regulations Amendment Number 165, 2006 come into effect on the day that this notice is published in *The Newfoundland & Labrador Gazette*. Anyone who wishes to inspect a copy of this Amendment may do so at the Mount Pearl City Hall, 3 Centennial Street during normal working hours.

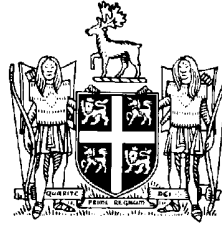

Mines Safety of Workers Regulations (Amendment)
under the
Occupational Health and Safety Act
(O.C. 2006-343)

(Filed August 7, 2006)

Under the authority of section 65 of the *Occupational Health and Safety Act*, the Lieutenant-Governor in Council makes the following regulations.

Training for rescue equipment

CNLR 1145/96

1. Section 111 of the *Mines Safety of Workers Regulations* is repealed and the following substituted:

Training for rescue equipment

111. (1) In this section "commission" means the Workplace Health, Safety and Compensation Commission established under the *Workplace Health, Safety and Compensation Act*.

(2) The operator and manager of a mine shall cause such workers and supervisors to be trained in the use and maintenance of mine rescue equipment as the commission considers necessary and the course of training to be followed shall be one approved by the commission.

(3) The operator of a mine shall provide and maintain the mine rescue equipment as the chief inspector considers necessary and this equipment shall be stored at an approved location.

(4) The manager of a mine shall be responsible for the supervision and direction of mine rescue crews in all mine rescue and recovery operations conducted at the mine.

(5) The manager of a mine shall immediately notify the chief inspector of circumstances necessitating rescue and recovery operations conducted by rescue crews wearing masks or self-contained breathing apparatus.

(6) Each person completing an approved course in the use and maintenance of mine rescue equipment may present himself or herself for examination as to his or her competency before an examination board consisting of an employee of or a person appointed for the purpose by the commission and an official of the mine at which he or she is employed.

(7) The commission may issue a certificate of mine rescue training to each person complying with the requirements of the examination board referred to in subsection (6).
