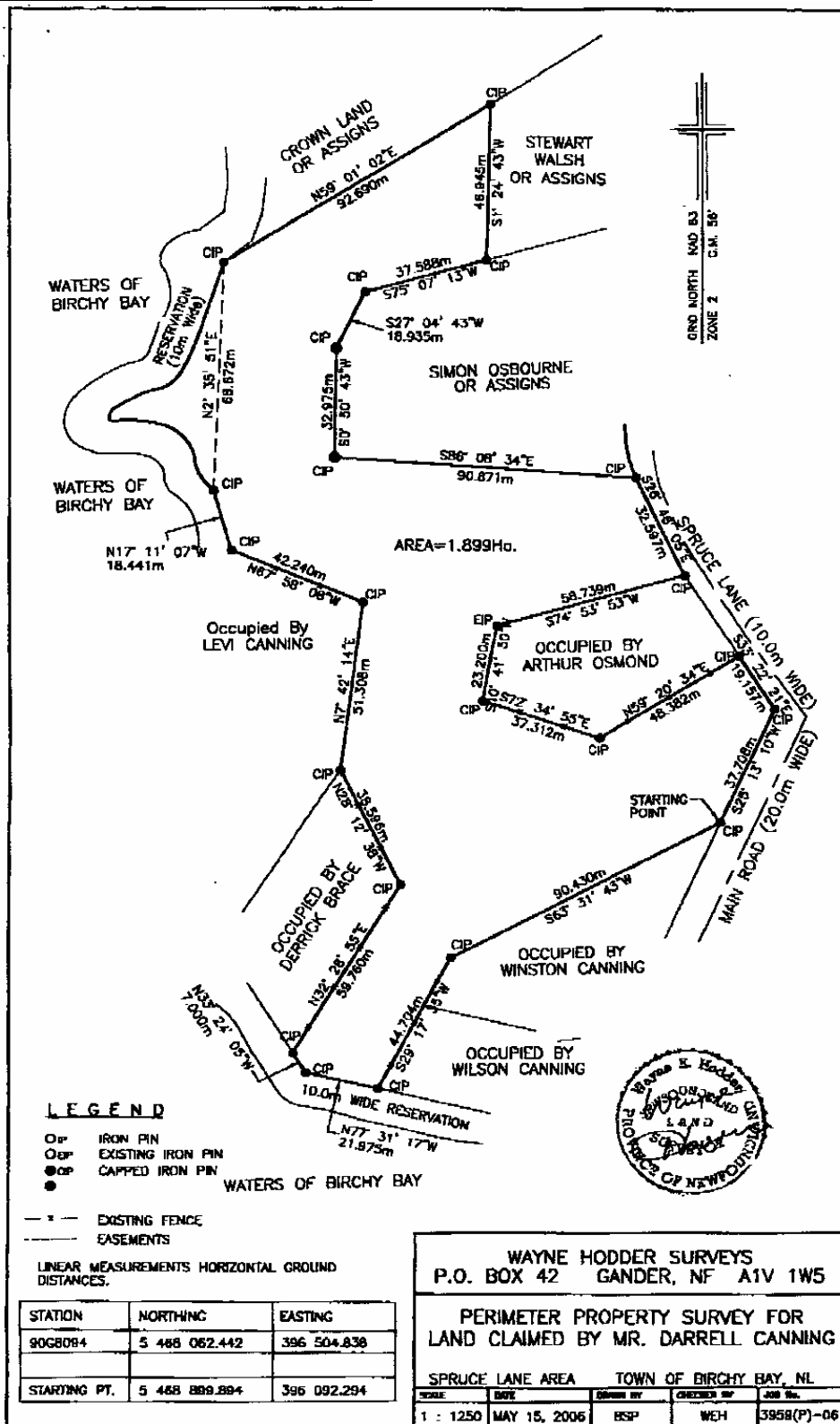

**1. The GOULDS - KILBRIDE Zone 1 in the Schedule to the *St. John's Urban Region Agriculture Development Area Order* is amended by adding at the end of that description the following:**
