In general terms the purpose of the Municipal Plan and Development Regulations amendments is enable the Town to:

- a) more effectively protect its municipal wells;
- b) allow mixed development up to the Colliers/Marysvale boundary;

- c) allow additional residential development off North Side Road and Harbour Drive and accommodate existing developments in these areas,
- d) allow commercial marinas in the residential designation and zone.

The Municipal Plan Amendment No. 2, 2006 and Development Regulations Amendment No. 2, 2006 come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*.

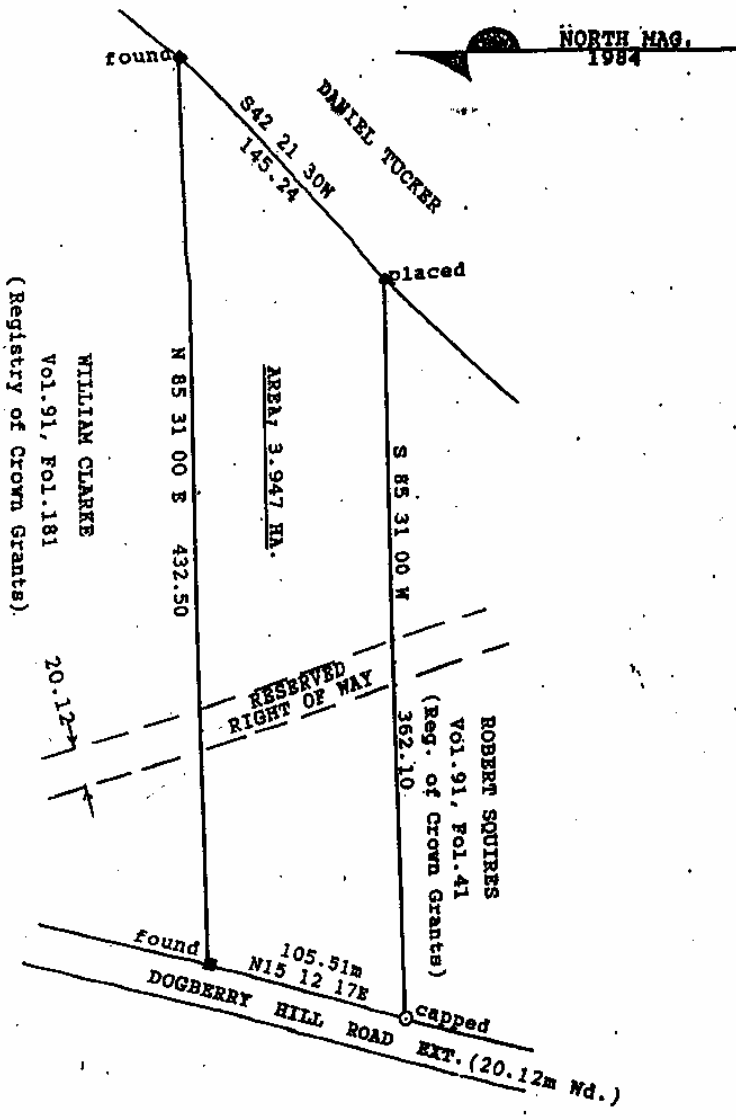
