Take notice that the Town of Carbonear Municipal Plan Amendment No. 4, 2006 and Development Regulations Amendment No. 6, 2006 approved on the 18th day of December, 2006, has been registered by the Minister of Municipal Affairs.

In general terms, the purpose of the Municipal Plan Amendment No. 4, 2006, is to re-designate two parcels of land. Parcel A, which is located south of the proposed location of the new building extension. This property, formerly of Land and Sea Welding, is to be re-designated from Industrial to Public Buildings. Parcel B is located west of the proposed building extension, and is a residential property which will be used as the main entrance off Cross Roads. This parcel is to be re-designated from Residential to Public Buildings.

The proposed Development Regulations Amendment No. 6, 2006 will re-zone the same parcels of land from "Industrial General" to "Public Buildings" and "Residential Medium Density" to "Public Buildings".

The Amendment is required to allow for a proposed extension to Charwood Legion Manor.

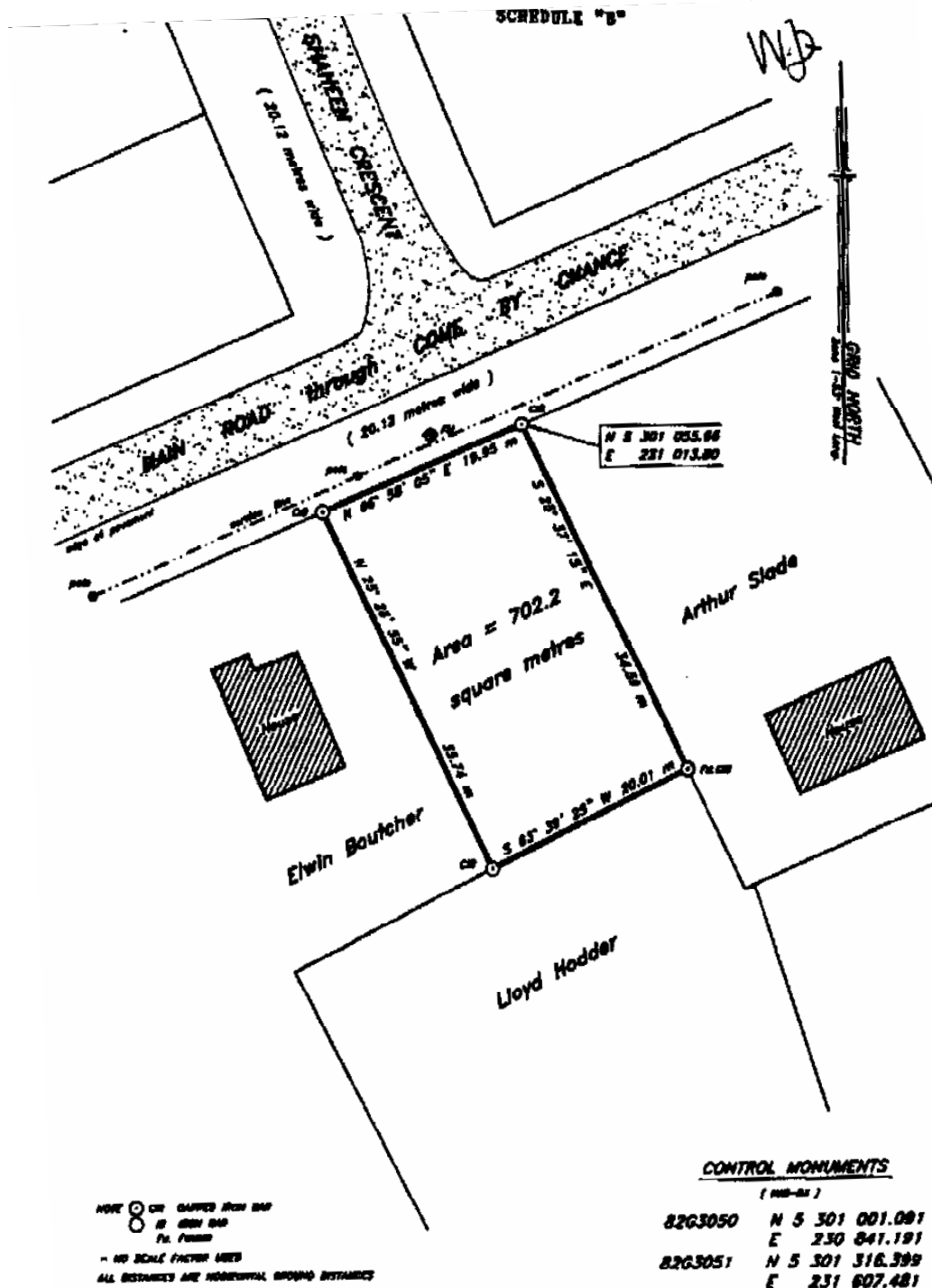


