Take notice that the Town of Grand Bank Municipal Plan Amendment No. 1 2006 and Development Regulations Amendment No. 1, 2006 as adopted on the 19th day of February, 2007 and approved on the 26th day of March, 2007, have been registered by the Minister of Municipal Affairs.

In general terms the purpose of the Municipal Plan and Development Regulations amendments is to accommodate existing cottages in the Town's water supply area - the area which is designated Conservation in the Municipal Plan and zoned Conservation in the Development Regulations.

Take notice that the Town of Gander Municipal Plan Amendment No. 15, 2007 and Development Regulations Amendment No. 20, 2007, adopted on the 21st day of February 2007, and approved on the 4th day of April, 2007, has been registered by the Minister of Municipal Affairs.

In general terms, the purpose of Municipal Plan Amendment No. 15, 2007 is to re-designate a parcel of land, approximately 1.6 hectares in size, located on Gander Bay Road, from Rural (RURAL) to Residential (RES).

The purpose of Development Regulations Amendment No. 20, 2007 is to re-zone the same parcel of land from Rural (R) to Rural Residential (RR).

The Gander Municipal Plan Amendment No. 15, 2007 and Development Regulations Amendment No. 20, 2007 come into effect on the day that this notice is published in the Newfoundland Gazette. NOTICE OF REGISTRATION TOWN OF GRAND FALLS – WINDSOR MUNICIPAL PLAN AMENDMENT NO. 1, 2007 AND DEVELOPMENT REGULATIONS AMENDMENT NO. 1, 2007

Take notice that the Town of Grand Falls – Windsor Municipal Plan Amendment No. 1, 2007 and Development Regulations Amendment No. 1, 2007, adopted on the 21st day of March, 2007, as amended and approved on the 10th day of April, 2007, has been registered by the Minister of Municipal Affairs.

In general terms, the purpose of Municipal Plan Amendment No. 1, 2007 and Development Regulations Amendment No. 1, 2007 is as follows:

- 1. The Commercial General Use Zone Table (Schedule C) shall be amended by:
 - a. adding "Shop" to the list of permitted uses.
 - b. adding "Light Industrial" to the list of discretionary uses.
 - c. adding the following condition to the Development Standards:

"Building line setbacks may be increased beyond 32 metres with the addition of a five metre landscaped buffer strip at the lot frontage for buildings with floor areas greater than 1,400 square metres. Authority defined buffer standards provided in Condition 2 will apply. Acceptable maximum setback distances beyond 32 metres to be determined by the Authority."

adding the following conditions as Condition 1.1
c) – Advertisements:

"Free standing signs may be permitted beyond the maximum area of 5 square metres at the discretion of the Authority".

e. adding the following conditions as Condition 3 – Outdoor Storage:

"Where temporary or semi-permanent outdoor storage structures may be permitted, external construction materials and overall appearance of said structures shall be clearly incidental, conform with and be complimentary to the external construction materials and overall appearance of the main building in character and size."

Including "garden centres" as an example of acceptable storage.

f. adding the following conditions as Condition 7 – Shopping Centre:

Including "Shops of 1,400 square metres or more of floor space" as being permitted uses subject to standards determined by the Authority.

2. The Off-Street Parking Requirements (Schedule D) shall be amended by:

a. revising the requirements for the "Medical and Professional" class from one space for every 20 metres of gross floor area to "as specified by the Authority".

3. The Land Use Zoning Map is amended accordingly.

The Municipal Plan Amendment No. 1, 2007 and Development Regulations Amendment No. 1, 2007 come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*.
