- Sections 1, 2, 3, 4, 6, 10, 11, 12, 13, 15, 16, 17, 18, 20, 21, 23, 25 and 26 of "An Act to Amend the Securities Act, No. 2", SNL2006 c42 shall come into force on the date of publication of this proclamation in *The Newfoundland and Labrador Gazette*;
- 2) Sections 5, 7, 8, 9. 19, 22 and 24 of "*An Act to Amend the Securities Act, No. 2*", SNL2006 c42 shall come into force on September 1, 2007; and

3) Section 14 of "*An Act to Amend the Securities Act, No. 2*", SNL2006 c42 shall come into force on May 1, 2008.
