In general terms, the purpose of St. John's Municipal Plan Amendment No. 49, 2007 is to redesignate land on the east side of Bay Bulls Road, south of Valleyview Road from the Rural Land Use District to the Residential Low Density Land Use District.

In general terms, the purpose St. John's Development Regulations Amendment No. 409, 2007, is to rezone land on the east side of Bay Bulls Road, south of the Valleyview Road, from the Rural (R) Zone and the Rural Residential Infill (RRI) Zone to the Residential Low Density (R1) Zone.

3. Add the following new subsection to Section 7.14 – Reduced Lot Housing Development.

“A Subsidiary Apartment shall not be permitted where a Reduced Lot Housing Lot has less than 15 metres Lot Frontage.”

4. Revise Section 10.3.1(d) – Subsidiary Apartments in the Residential Low Density (R1) Zone to read as follows.

“(d) Subsidiary Apartment (subject to Section 7.14)”
