> a) to expand significantly the potential for commercial development to the west and north of present Walmart site centred on the extension of Thompson Street;

> b) to provide for mixed residential commercial development to the west and south of the above;

c) to accommodate additional commercial development on the east of Shoal Harbour Drive to the back of the Hospital and the Random Mall off the extension of Thompson Street;

d) to provide for commercial development south of Manitoba Drive - Blackmore Avenue and Blackmore Extension.

 Municipal Plan Amendment No. 11 and Development Regulations Amendment No. 18: redesignate and rezone properties at 131 and 222 Marine Drive to Mixed Residential/Commercial in order to accommodate a tourist facility and apartments in existing buildings.

 Municipal Plan Amendment No. 10: change the Town's municipal plan policies in respect of the Shoal Harbour Valley Collector Street in order to provide for greater development flexibility.

The Municipal Plan Amendments Nos. 9, 10 and 11, 2007 and Development Regulations Amendments Nos. 17 and 18, 2007 come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*.
