In general terms, the purpose of St. John's Municipal Plan Amendment No. 51, 2007 is to redesignate land at Civic Number 615 Empire to the Commercial General Land Use District.

In general terms, the purpose of St. John's Development Regulations Amendment Number 416, 2007 is to rezone land at Civic Number 615 Empire Avenue to the Commercial Mixed (CM) Zone with site-specific restrictions.

The purpose of Development Regulations Amendment No. 22, 2007 is to re-zone the same parcel of land from Open Space Recreation (OSR) and Public/Institutional (PI) to Residential Medium (RMD).

Take notice that the Town of Steady Brook Municipal Plan Amendment # 6, 2007 and Development Regulation Amendment # 8, 2007 as approved by Council on the 21<sup>st</sup> November, 2007, has been registered by the Minister of Municipal Affairs.

In general terms, the purpose of Municipal Plan Amendment # 6 is comprised of three amendments to the Future Land Use Map—

- a) Land to the south of the Trans Canada Highway on which is located Marblewood Village which previously had a Residential designation is amended to the Tourist-Commercial designation.
- b) Land fronting onto and to the south of Marble Drive and to the west of a drainage channel previously designated for Mixed Development is amended to the Tourist-Commercial designation and
- c) Land fronting onto and to the south of Marble Drive and to the east of a drainage channel previously designated for Mixed Development is amended to the Residential designation.

In general terms, the purpose of Development Regulation # 8 is comprised of three parts of which are amendments to the Land Use Zoning Map corresponding to the above noted Municipal Plan Amendments # 6, namely—

- a) The Marblewood Village area is rezoned from Residential Medium Density(RMD) to Commercial-Tourist(C-T).
- b) Land off Marble Drive and west of the drainage channel is rezoned from Mixed Development(MD) to Commercial-Tourist(C-T) and
- c) Land off Marble Drive and to the east of the drainage channel is rezoned from Mixed

Development(MD) to Residential Medium Density(MD)

and in the Residential Medium Density(RMD) zone the minimum Rear Yard requirement for all residential types is reduced to 8 meters from 14 meters.

The Municipal Plan Amendment # 6, 2007 and Development Amendment # 8, 2007 come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*.
