# 1. Section 22 of the *Milk Regulations*, 1998 is repealed and the following substituted:

Minimum price for milk

**22.** The minimum price at which milk shall be bought, sold or offered for sale FOB registered processors premises in the province shall be \$98.45 per hectolitre of standard milk containing 3.6 kilograms of

butterfat, and for every kilogram in excess of that butterfat content, the minimum price shall be adjusted by the amount of \$3.20 per hectolitre.

Commencement

2. This regulation shall come into force on February 1, 2008.
