A PROCLAMATION

WHEREAS a General Election of Members of the General Assembly of the Province of Newfoundland and Labrador was held on October 9, 2007;

AND WHEREAS under section 128 of the *Constitution Act, 1867*, the Lieutenant Governor of the Province of Newfoundland and Labrador administered the Oaths or Affirmations of Allegiance to Her Majesty Queen Elizabeth II to those persons elected to be Members of the House of Assembly in the said General Election on November, 1, 2007;

AND WHEREAS the Members of the Forty-Sixth House of Assembly chose their Speaker on November 1, 2007;

AND WHEREAS I think fit to summon the Forty-Sixth General Assembly;

I DO, THEREFORE, by this My Proclamation summon the said General Assembly to meet for the dispatch of business of the First Session of the Forty-Sixth General Assembly at 2:00 p.m. on Monday, the 10th day of March, 2008 of which all persons concerned are hereby required to take due notice and govern themselves accordingly, and at which time I shall give my appropriation to the Speaker elected on November 1, 2007.

WITNESS: Our trusty and well-beloved the Honourable John Carnell Crosbie, Member of the Privy Council of Canada, an Officer of the Order of Canada, and one of Her Majesty's Counsel learned in the law, Lieutenant Governor in and for Our Province of Newfoundland and Labrador

AT OUR GOVERNMENT HOUSE in Our City of St. John's this 5th day of March in the year of Our Lord two thousand and eight and in the fifty-seventh year of Our Reign.

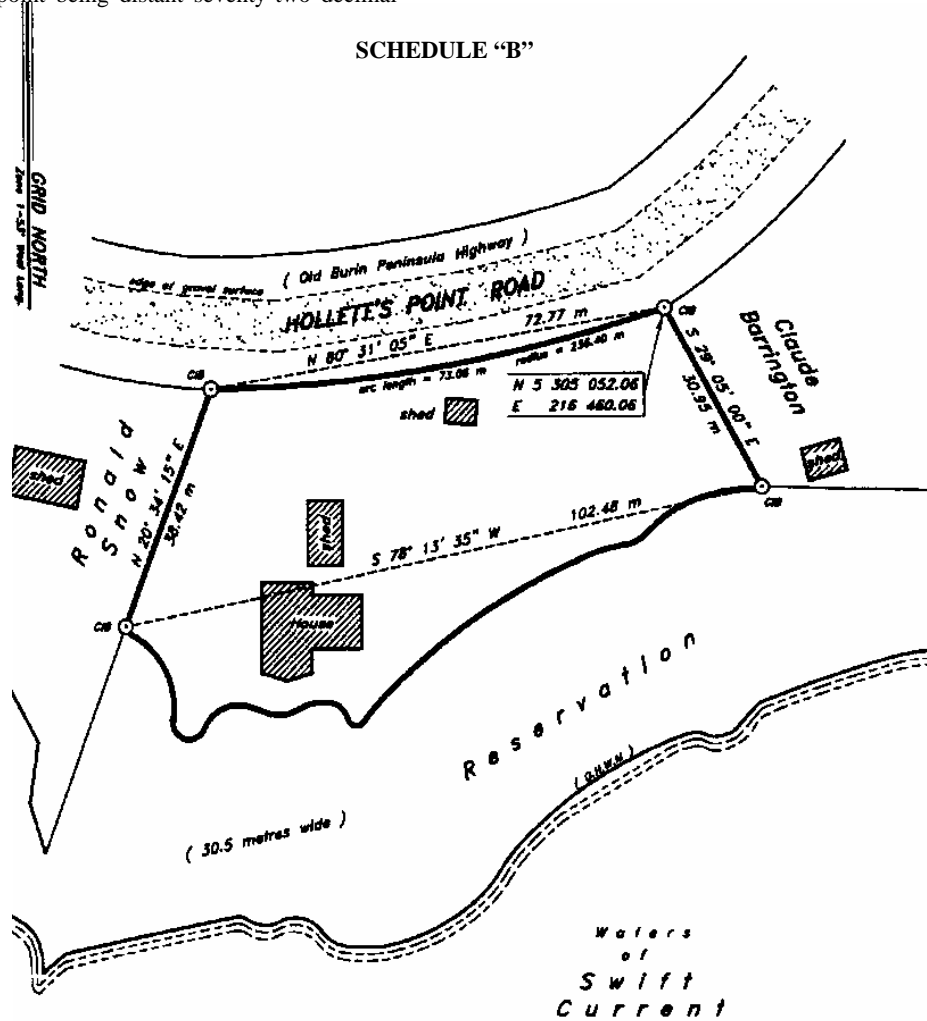
