The following Practice Note was filed with the Registrar, as Secretary of the Rules Committee of the Trial Division, and is published pursuant to rule 4.04 of the *Rules of the Supreme Court, 1986*.

NATIONAL DATA BASE OF CLASS PROCEEDINGS

Background

1. The Canadian Judicial Council has endorsed the recommendation of the Uniform Law Conference of Canada for the creation of a Canadian Class Proceedings Database to facilitate the exchange of information about multi-jurisdictional class proceedings.

2. The Canadian Bar Association has announced a pilot project to establish such a Database and this Practice Note is used to support the initiative.
3. Similar practice notes or directions have already been issued in a number of provinces. It is anticipated that similar procedures will be implemented across the country and that lawyers and members of the public will be able to search the Database to obtain information about class action proceedings that have been commenced in any jurisdiction in Canada.

Practice Note

4. For existing class proceedings, within sixty days of the effective date of this Practice Note, and for new class proceedings, within ten days of service or filing, whichever is earlier, a copy of any:
 - (1) originating process (statement of claim or originating application issued under the *Class Actions Act*, SNL 2001, c. C-18.1);
 - (2) application for certification (not including affidavits in support); and
 - (3) amendments to the foregoing.must be sent electronically by counsel for the plaintiff(s) to the National Class Action Database of the Canadian Bar Association at the following address:

5. The registration form attached as Schedule “A” to this Practice Note, completed preferably in MS Word format, must be included as an attachment to the email when submitting documents to the National Class Action Database, with data entered electronically. A copy of this registration form may be obtained online through the above email or website. With respect to documents accompanying the registration form, PDF is the preferred format; however, MS Word documents will also be accepted.
6. Upon submitting the registration form, counsel must also file in the Court a copy of the registration form, attached to a certificate in the form annexed as Schedule “B” to this Practice Note, confirming compliance with paragraph 4.
7. Counsel for the plaintiff(s) is responsible for verifying the accuracy of the information posted to the Canadian Bar Association website and for advising the Database of any changes to information already posted.
8. The Canadian Bar Association advises that an RSS (“Really Simple Syndication”) feed is available to push news of an update to the Database to anyone who chooses to subscribe to it.

HIGHWAY TRAFFIC ACT

TOWN OF STEPHENVILLE TRUCK TRAFFIC BY-LAW Passed by Council on July 31, 2008

Under and by virtue of the powers conferred by Sections 189 and 190 of the *Highway Traffic Act*, RSNL 1990 and pursuant to a delegation of power by the Minister of Transportation and Works dated January 15, 1996, the Town of Stephenville enacts the following by-law relating to the control of truck traffic within the Town of Stephenville.

STEPHENVILLE TRUCK TRAFFIC BY-LAW

1. This by-law may be cited as the "Stephenville Truck Traffic By-law".
2. For the purposes of this By-law:
 - (a) "Designated Area" means the area of Main Street between its intersection with Queen Street and its intersection with Boland Drive;
 - (b) "Inspector" means any official or employee of the Town or other person or persons designated by the Town to enforce the provisions of this By-law;
 - (c) "Vehicle" means all vehicles with a registered weight in excess of 16,750 kilograms.
 - (d) "Person" includes the driver, operator, or owner of a vehicle as described in (c) above.
3. (1) No person shall cause to operate, permit to operate, or operate a Vehicle within a Designated Area unless the

- Vehicle has a specified destination with the Designated Area; and
- (2) Proof of a destination within a Designated Area shall be produced upon request of the Inspector
4. Any person who contravenes the provisions of this By-law shall be guilty of an offence and liable upon summary conviction to a penalty as provided for in Section 420 of the Municipalities Act, 1999.

1. Subsection 3(3) of the *Fish Inspection Administrative Regulations* is repealed and the following substituted:

(3) Except as otherwise provided in section 4 a person shall not engage in, or engage in a specific aspect of, processing except under authorization of a fish processing licence issued by the minister.

2. (1) Paragraph 4(b) of the regulations is amended by striking out the word "purchasing" and substituting the word "marketing".

(2) Paragraph 4(c) of the regulations is repealed and the following substituted:

- (c) a person purchasing fish for personal consumption directly from
 - (i) a fish processor who is licensed under the Act and the regulations,
 - (ii) a person licensed under section 5 of the *Food Premises Regulations*, or
 - (iii) a person referred to in paragraph (d);

(3) Paragraph 4(d) of the regulations is repealed and the following substituted:

- (d) a person purchasing fish for resale without further processing from a fish processor who is licensed under the Act and the regulations; or

(4) Paragraph 4(e) of the regulations is amended by striking out the words "Food Premises Act" and substituting the words "Food Premises Regulations".

3. Paragraph 7(1)(a) of the regulations is amended by striking out the words "minimum authorized treatment requirements" and substituting the words "minimum processing requirements" and by striking out the words "alternative treatments" and substituting the words "minimum processing requirements".

4. Paragraph 18(3)(b) of the regulations is repealed and the following substituted:

- (b) to a corporation, by

- (i) personal delivery to a director or chief executive officer of that corporate body at the address provided to the minister for that purpose,
- (ii) registered mail or other mail delivery which produces a receipt or other proof of delivery, to the registered office of that corporate body in the province, or
- (iii) personal delivery to the corporation's counsel, provided that counsel may accept service of that notice in the province.
