Take notice that the Town of Irishtown-Summerside Municipal Plan Amendment No. 3, 2008 and Development Regulations Amendment No. 4, 2008 adopted on the 8th day of October, 2008 and approved on the 5th day of November, 2008, have been registered by the Minister of Municipal Affairs.

In general terms the purpose of Municipal Plan Amendment No. 3, 2008 and Development Regulations Amendment No. 4, 2008 is to accommodate additional residential development back of properties fronting on Main Street (Highway 440). This will entail expanding the Rural Residential Infill designation and zone an additional 190 to 200 metres beyond the current area so designated and zoned.
