



This Order acknowledges the condition attached to the provin-Women's employment plan cial release from further environmental assessment dated August 26, 2008 from the Minister of Environment and Conservation that relates to the development of a women's employment plan for the project. 7. This Order acknowledges the commitment contained in the Human resources plan Voisey's Bay Industrial and Employment Benefits Agreement, 2002 with respect to the implementation of a human resources plan for the project. 8. This Order remains in effect until all construction, including Duration of Order mobilization and demobilization and all commissioning as defined in the agreement, for the project has been completed and Vale Inco NL Ltd., or such other authority as they may designate, has issued the appropriate certificates of completion to the contractors as defined in the agreement.
