Development Regulations Amendment No. 34 -2008 re-zones the same lands from their respective designations to “Residential Medium Density”.

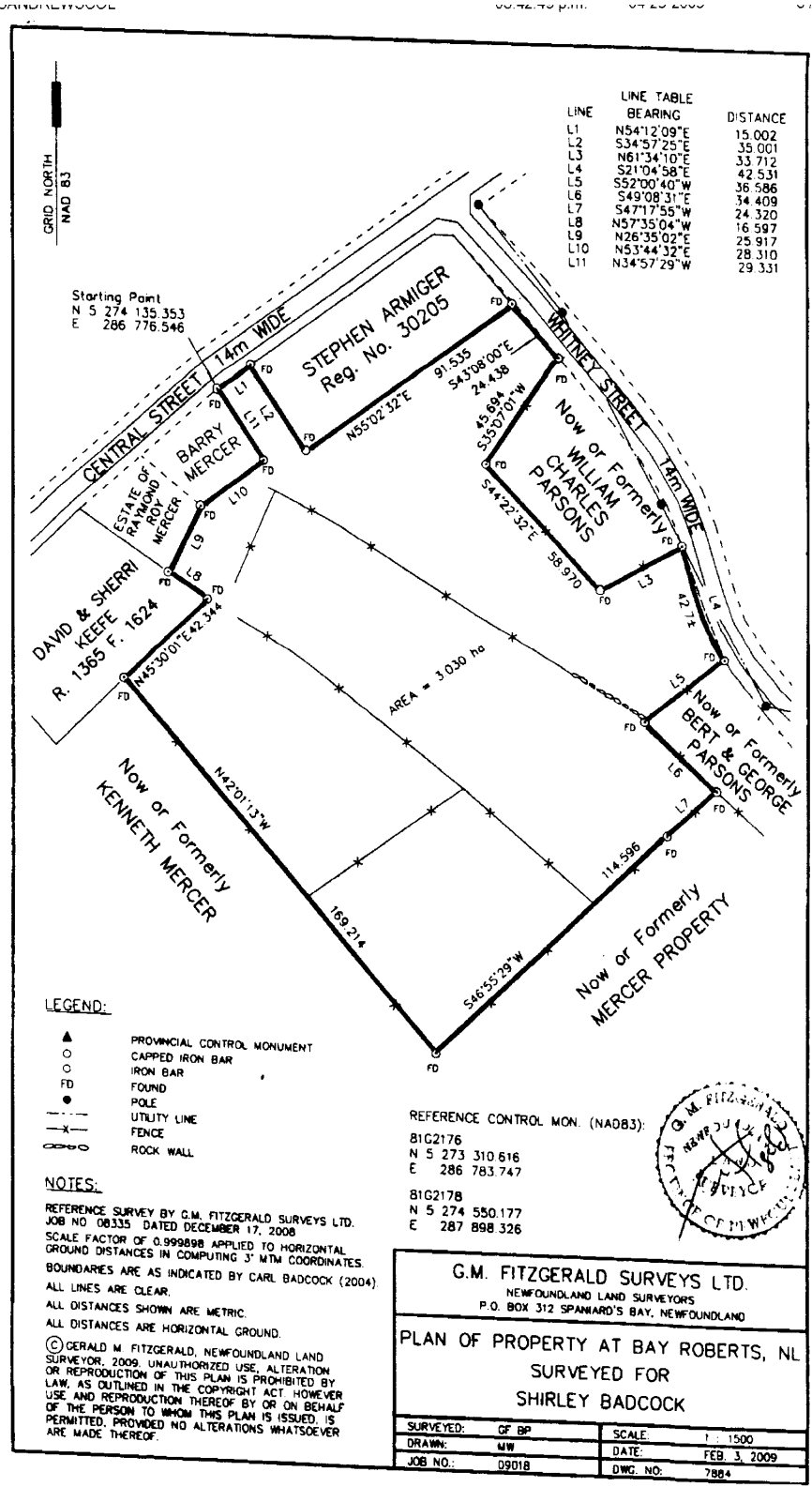
