1. This order may be cited as the *Town of Long Harbour-Mount Arlington Heights Order*, 2010.

2. The boundaries of the Town of Long Harbour-Mount Arlington Heights are as set out in the Schedule.

3. The *Town of Long Harbour-Mount Arlington Heights Order*, Consolidated Newfoundland and Labrador Regulation 276/96, is repealed.

Then following the southern shoreline of Broad Cove Pond to Tommy LeGrow's Brook;

Then following the centre line of Tommy LeGrow's Brook to Tommy LeGrow's Pond;

Then following the western shoreline of the pond to the mouth of a small brook which flows into Tommy LeGrow's Pond;

Then running south 87° east 1,700 metres, more or less, to a point in the centre line of the Conception Bay North main highway;

Then running south 55° east 600 metres, more or less, to the western shoreline of Conception Bay;

Then running in a generally northeasterly direction along the shoreline to the point of beginning.

All bearings being referred to the true meridian.
