Then following the centre thread of the unnamed stream to a point on the centre line of the highway to Seal Cove directly above the pond;

Then in a generally northeasterly direction to where an unnamed stream flows into Western Cove;

Then following the sinuosities of the shoreline in a generally easterly direction to the northwesternmost extremity of Connaigre Head;

Then in a generally southeasterly direction to the highest elevation of Devils Knob;
