MOUNT PEARL BUILDING REGULATIONS 2011 NOTICE OF ADOPTION

TAKE NOTICE that the MOUNT PEARL CITY COUNCIL has adopted an amendment to the City of Mount Pearl Building Regulations 2010 made and adopted by the City Council pursuant to the *City of Mount Pearl Act* on February 8th, 2011.

The purpose of the amendment is to adopt the 2010 edition of the *National Building Code of Canada*, the *National Fire Code* and the *National Plumbing Code of Canada* and to revise the Regulations so that future editions of these codes automatically form a part of the Regulations.

NOTICE OF INTENT Lands Act c36, SNL 1999

NOTICE is hereby given that RICHARD D.
