

- 1. Section 3 of the *Diagnostic and Therapeutic Drug Regulations* is amended by adding immediately after subsection (3) the following:
- (4) An optometrist who holds a therapeutic drug certificate may administer and prescribe the following pharmaceutical agents for the diagnosis and treatment of conditions of the ocular surface and adnexa where there is no corneal ulceration:
 - (a) topical ocular corticosteroids; and
 - (b) topical ocular anti-infective corticosteroid combinations.
