GREETING;

A PROCLAMATION

WHEREAS in and by section 8 of “*An Act Respecting the Mandatory Reporting of Gunshot and Stab Wounds*,” Statutes of Newfoundland and Labrador 2011, Chapter G-7.1 (the “Act”) it is provided that the Act shall come into force on a date to be fixed by Proclamation of Our Lieutenant Governor in Council;

AND WHEREAS it is deemed expedient that the Act shall now come into force;

NOW KNOW YE, THAT WE, by and with the advice of Our Executive Council of Our Province of Newfoundland and Labrador, do by this our Proclamation declare and direct that “*An Act Respecting the Mandatory Reporting of Gunshot and Stab Wounds*,” Statutes of Newfoundland and Labrador 2011, Chapter G-7.1.1 shall come into force on March 1, 2015.

Short title	1. These regulations may be cited as the <i>Gunshot and Stab Wound Reporting Regulations</i> .
Definition	2. In these regulations, "Act" means the <i>Gunshot and Stab Wound Reporting Act</i> .
Reporting	3. (1) The period of time referred to in subsection 4(1) of the Act is no later than 24 hours after treatment of the gunshot or stab wound.

(2) For the purpose of subsection (1), treatment shall be considered to be given when that treatment is offered.

Commencement

4. These regulations come into force on the day the *Gunshot and Stab Wound Reporting Act* comes into force.
