NOTICE IS HEREBY given that ROSE PORTER of Woody Point, Bonne Bay, Newfoundland and Labrador intends to apply to the Department of Municipal Affairs, two months from the publication of this notice, to acquire title, pursuant to Section 7(2) of the said Act, to that piece of Crown land situated within fifteen (15) metres of the waters of Bonne Bay in the Electoral District of Humber - Gros Morne for the purpose of building shed and boat slip, 10' x 20' north of existing wharf and shed of 82'x 33' and being more particularly described as follows:
