### NOTICE OF REGISTRATION TOWN OF BISHOP'S FALLS MUNICIPAL PLAN AND DEVELOPMENT REGULATIONS

TAKE NOTICE that the TOWN OF BISHOP'S FALLS Municipal Plan Amendment No. 1 and Development Regulations Amendment No. 1, adopted on the 21<sup>st</sup> day of July, 2017, have been registered by the Minister of Municipal Affairs and Environment.

The intent of the amendment is to permit mini homes to be developed in these areas to replace existing mobile homes. Council may also consider approval of new single dwellings in these areas subject to conditions to ensure they will be compatible with existing housing.

These amendments come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*. Anyone who wishes to inspect a copy of the documents may do so at the Bishop's Falls Town Office during normal business hours.

### NOTICE OF REGISTRATION CITY OF CORNER BROOK DEVELOPMENT REGULATIONS AMENDMENT DR17-05

TAKE NOTICE that the CITY OF CORNER BROOK Development Regulations Amendment DR17-05, adopted on the 21<sup>st</sup> day of August, 2017, has been registered by the Minister of Municipal Affairs and Environment.

In general terms Development Regulations Amendment DR17-05 is necessary to create a new land use zoning map, Map C5 in order to identify the land use zoning of land beyond the more developed areas of the CITY OF CORNER BROOK (currently identified on Maps C-1, C-2, C-3 and C-4) and to correspond with the land use designations identified on the Integrated Municipal Sustainability Map A and Map B. Currently only Land Use Designation Maps A and B exist for these areas. Zoning amendments for these outlying areas may also then be identified and processed.

The CORNER BROOK Development Regulations Amendment DR17-05 comes into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*. Anyone who wishes to inspect a copy of the CORNER BROOK Development Regulations DR17-05 may do so at City Hall, Corner Brook during normal business hours.
