## INSTRUCTIONS

### Item 1

The proposed name must comply with Section 60 of the *Partnership Act*. Please ensure that the name has the words "Limited Liability Partnership" or the abbreviation "LLP" as part of and at the end of its name.

### Item 2

In this section please indicate whether the registration is for a Newfoundland and Labrador LLP or for an extra-provincial LLP that was formed in another jurisdiction. If this form is for an extra-provincial registration please indicate home jurisdiction and include constating documents (certificate, registration and any changes to the registration).

### Item 3

The name and residential address in the province of the partner who is your designated representative with matters relating to the partnership (See Sections 55 (c) or 67(e) of the *Partnership Act*).

### Item 4

Please state the full civic address in Newfoundland and Labrador where the registered office will be situated. If the mailing address is different please clearly indicate in the space provided. (See Sections 55(d) or 67(e) of the *Partnership Act*).

### Item 5

Description of the eligible profession. (An eligible profession means a profession or occupation that is governed or regulated by a body created by or under an Act. The Acts that govern the eligible professions in Newfoundland and Labrador are Architects Act, 2008, Chartered Professional Accountants and Public Accountants Act, and Engineers and Geoscientists Act, 2008. Members of a professional partnership cannot register as an extra-provincial LLP unless they are authorized by or under the Act by which that profession is governed in this province to carry on the practice of the profession through a limited liability partnership).

### Item 6

The partner must state their name and affix their signature.

## PLEASE NOTE

- With your registration you are required to include a letter of consent containing a statement from a person who is authorized by the governing body of the applicable eligible profession.
- To provide a statement certifying that the partnership and the partners meet all applicable eligibility requirements for practice as a limited liability partnership that is imposed under the act that regulates the eligible profession. (See sections 55(e) or 67(f) of the *Partnership Act*).
- A Registration fee of \$300 is required. Please make cheque payable to Newfoundland Exchequer Account.
