The original Permit dated OCTOBER 14, 2020 is amended as follows:

As per the email request of Kevin Chafe dated May 25, 2021, the permit is being amended as follows:

- 1. Original shed in 1:20 year flood zone at 47.464600N, 52.707047W is being relocated to 1:100 year flood zone at 47.464708N, 52.706973W, as shown on the location map in Appendix E.
- 2. Original shed size 4 feet x 4 feet is being changed to 10 feet x 16 feet to accommodate washroom, as shown on the location map in Appendix E.
- 3. Following new term and condition under Flood Zone Development will be applicable:
 - The ground floor elevation for the shed must be constructed 0.6 m above the estimated 1:100 year climate change flood elevation 2.84 m for the area.

All other terms and conditions of the original Permit will apply and failure to comply with the terms and conditions of this amendment and the original Permit will render this Permit null and void, place the Permit Holder and their agent(s) in violation of the *Water Resources Act* and make the Permit Holder responsible for taking any remedial measures as may be prescribed by this Department.
