## The original Permit dated JANUARY 19, 2023 is amended as follows:

the extension of the lift station overflow pipe has been removed from the project. A new 200 mm diameter end cap will be installed on the existing sewage lift station overflow pipe and an emergency generator is being provided for this lift station to allow for continued operation during a power outage as shown on a drawing received from Meridian Engineering Inc. on November 2, 2023.

All other terms and conditions of the original Permit will apply and failure to comply with the terms and conditions of this amendment and the original Permit will render this Permit null and void, place the Permit Holder and their agent(s) in violation of the *Water Resources Act* and make the Permit Holder responsible for taking any remedial measures as may be prescribed by this Department.
