Vendor Terms & Conditions

Commercial Category

1. For the purpose of this licence, all definitions and regulations as indicated in the *Environmental Protection Act, SNL 2002, c.E-14.2* and the *Pesticides Control Regulations 2012* shall apply.
2. The sale of a commercial or restricted class pesticide shall only be made by a certified pesticide vendor in the business vendor's employ. The certified vendor's name and certified vendor licence number shall be noted in the record of sale of each sale of a commercial or restricted class pesticide, as per Section 9 of these terms and conditions.
3. The business vendor shall keep all commercial or restricted class pesticides in a secure locked facility accessible only to the certified pesticide vendor(s) listed in Section 11 of these terms and conditions.
4. In accordance with Section 14 of the *Pesticides Control Regulations, 2012*, the vendor shall not sell any pesticide registered for use only on lawns which contain any of the following active ingredients:
 - a. 2,4-dichlorophenoxyacetic acid, commonly referred to as **2,4-D**;
 - b. **Mecoprop**;
 - c. **Dicamba**;
 - d. 2-methyl-4chlorophenoxyacetic acid, commonly referred to as **MCPA**; or **Carbaryl**.
5. The business vendor shall only sell the above noted pesticides to a licenced pesticide operator with a landscape category provided that the operator is either a golf course or has a permit from the Pesticides Control Section to purchase the above noted pesticides for use on turf.
6. The business vendor shall not sell a commercial or restricted class pesticide to anyone other than a licenced pesticide operator unless the pesticide is designated on the label for agricultural use or for use in a greenhouse and the purchaser is a

licensed pesticide applicator with a valid agriculture or greenhouse designation. The business vendor shall obtain proof of eligibility of the purchaser to purchase a commercial or restricted class pesticide at the time of sale of the pesticide.

7. The business vendor shall make no cash sale transaction of a commercial or restricted class pesticide. All sales of such pesticides shall be billed directly to the pesticide operator, or to the pesticide applicator, if the sale to the pesticide applicator meets the criteria noted in Section 6 of these terms and conditions.
8. The business vendor shall not sell to a licenced pesticide operator a pesticide that is not listed on the Pesticide Operator Licence, Appendix A, Pesticide List, of that operator.
9. The business vendor shall keep a record of each purchase and sale of a pesticide. The record of sale of a pesticide shall contain:
 - (a) Name of the purchaser
 - (b) Licence Number:
 - (i) POL # (Pesticide Operator Licence Number); or
 - (ii) PAL # (Pesticide Applicator Licence Number, as per section 6 of these terms and conditions)
 - (iii) Permit Number if applicable (as per section 5 of these terms and conditions)
 - (c) Date of sale of pesticide
 - (d) Type and Quantity sold
 - (e) Unit of measure
 - (f) Certified pesticide vendor's name, and certified pesticide vendor licence number
10. The following certified pesticide vendor(s) shall be permitted to sell a commercial or restricted class pesticide under this business vendor licence:
