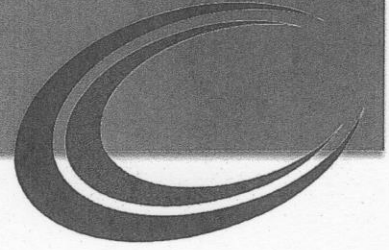

No'kmaw Village (The Flat Bay Band Inc.) is 50 years old - the oldest band surviving in the province, outside of the Miawpukek Reserve, which we helped form. Mi'kmaw Individuals make up our membership, within 4 generations. They reside within the village of Flat Bay, and across the province and nation.

With vast connections, we often outreach beyond our vicinity to mentor other organizations and Indigenous peoples. For the island portion of the province, we are a major employer, cultural mentor and one of the largest vulnerable profiles -serving organizations. We effectively operate more individual programs and service than any other band, including the Qalipu First Nation band.

In the matter of this proposal submitted by Atlas Salt, the Flat Bay Band Inc. fully supports the proposal for a salt mine in the area outlined by the company. With the potential to be extremely efficient, environmentally friendly and the need for economic stimulus in our area we are very supportive. We have been engaged in discussions for many months and is very impressed with the company's expertise and the respect for our engagement.

Our Mi'kmaq traditions also direct us to share our knowledge and best efforts among our nation. The sharing of knowledge and skills is integral to who we are as a people, and how we have survived culturally regardless of efforts to silence us.
