The original Permit dated OCTOBER 27, 2022 is amended as follows:

PRO12798 is to include the addition of a gravel driveway and a removeable wharf with reference to the amendment application dated November 6, 2023. This permit amendment relates to Crown Lands Referral #161762.

PRO12798 is to include the following condition under **Special Conditions**:

43. Wastewater must be disposed of in an approved septic disposal system or at an approved waste disposal site outside the Protected Public Water Supply Area, in accordance with the *Environmental Protection Act. SNL 2002 CE-14*.

All other terms and conditions of the original Permit will apply and failure to comply with the terms and conditions of this amendment and the original Permit will render this Permit null and void, place the Permit Holder and their agent(s) in violation of the *Water Resources Act* and make the Permit Holder responsible for taking any remedial measures as may be prescribed by this Department.
