General

- The Water Resources Management Division, in partnership with Rambler Metals and Mining Canada Ltd., maintain one real-time water quality and water quantity station at the Outflow of the Steady.




Figure 1: Location of the real-time station downstream of Rambler's Nugget Pond Mill tailings management facility

- This station is situated downstream of the Nugget Pond Mill tailings management facility (Figure 1).
- On August 14, 2020, a real-time water quality monitoring instrument was deployed at the station Outflow of the Steady. The instrument was deployed for a period of 102 days. This was the third and final deployment for this station in 2020.
- The instrument was removed from service for the winter season on November 26, 2020.
- Water Resources Management Division staff monitor the real-time web pages regularly.

Quality Assurance and Quality Control

- As part of the Quality Assurance and Quality Control protocol (QA/QC), an assessment of the reliability
 of data recorded by an instrument is made at the beginning and end of the deployment period. The
 procedure is based on the approach used by the United States Geological Survey.
 - At deployment and removal, a QA/QC Sonde is temporarily deployed adjacent to the Field Sonde. Values for temperature, pH, conductivity, dissolved oxygen and turbidity are compared between the two instruments. Based on the degree of difference between parameters recorded by the Field Sonde and QA/QC Sonde at deployment and at removal, a qualitative statement is made on the data quality (Table 1).

It should be noted that the temperature sensor on any sonde is the most important. All other parameters can be broken down into three groups: temperature dependant, temperature compensated and temperature independent. Because the temperature sensor is not isolated from the rest of the sonde the entire sonde must be at the same temperature before the sensor will stabilize. The values may take some time to climb to the appropriate reading; if a reading is taken too soon it may not accurately portray the water body.

Deployment and removal comparison rankings for the station Outflow of the Steady deployed between August 14 and November 26, 2020 are summarized in Table 2.

- Deployment rankings were either 'excellent' or 'fair' for all sensors.
- At removal, rankings were either 'excellent', 'good' or 'fair'.
- There are a few circumstances which may cause less than ideal QA/QC rankings to be obtained. These include: the placement of the QA/QC sonde in relation to the field sonde; the amount of time each sonde was given to stabilize before readings were recorded; and deteriorating performance of one of the sensors.

Data Interpretation

- The following graphs and discussion illustrate water quality related events from August 14 to November 26 at the station Outflow of the Steady.
- With the exception of water quantity data (stage), all data used in the preparation of the graphs and subsequent discussion adhere to this stringent QA/QC protocol. Corrected data can be obtained upon request.

Outflow of the Steady




Figure 2: Water and Air Temperature – Outflow of the Steady

- Water temperature ranged from 1.33 to 22.52°C during this deployment period (Figure 2).
- Water temperature gradually decreased during the deployment. The decrease corresponds with ambient air temperature as summer changes into fall (Figure 2).





Figure 3: Water pH and Stage - Outflow of the Steady

- pH ranged between 6.86 and 7.23 pH units throughout the deployment period, with a median value of 7.07 units (Figure 3).
- All values during the deployment are within the CCME Guidelines for the Protection of Aquatic Life (between 6.5 and 9 pH units). pH fluctuates slightly during the day and night.
- Significant rainfall (evident as a rise in stage levels) can cause a slight dip in pH levels. This is a common occurrence in freshwater as the slightly acidic rain influences the overall pH of the river for a short period of time. This relationship was evident on October 10th (Figure 3: as stage rose, pH decreased.
- Overall, pH was stable during the deployment.

Water pH and Stage Level: August 14 to November 26, 2020




Figure 4: Specific Conductivity of Water and Stage - Outflow of the Steady

- Specific conductivity ranged from 133.5 to 171.3 μs/cm (Figure 4).
- Specific conductivity increased slightly during the deployment.
- With the exception of water quantity data (stage), all data used in the preparation of the graphs and subsequent discussion adhere to this stringent QA/QC protocol. Corrected data can be obtained upon request.

Specific Conductivity of Water and Stage Level:




Figure 5: Dissolved Oxygen and Water Temperature – Outflow of the Steady

- The saturation of dissolved oxygen ranged from 82.2% to 100.1% and a range of 7.77 to 13.43 mg/l was recorded for the concentration of dissolved oxygen with a median value of 10.01 mg/l (Figure 5).
- All values were above the minimum CCME Guideline for the Protection of Other Life Stages of Cold Water Biota of 6.5 mg/l. The majority of values were above the minimum CCME Guideline for the Protection of Early Life Stages of Cold Water Biota value of 9.5 mg/l. The guidelines are indicated in red on Figure 5.
- Dissolved oxygen content fluctuates diurnally, displaying the inverse relationship to water temperature.
 Dissolved oxygen increased during this deployment period as water temperatures cooled and continued to fluctuate throughout the deployment period.

- Turbidity values range from 1.2 NTU to 3.1 NTU with a median of 1.6, indicating very clear background turbidity.




Figure 6: Turbidity and Stage - Outflow of the Steady

- Turbidity increased when water levels increased and decreased when stage decreased (Figure 6). This
 indicates rainfall may assist in flushing out sediment from the brook.

Water Turbidity and Stage Level: August 14 to November 26, 2020




Figure 7: Precipitation and Stage - Outflow of the Steady

- Precipitation and stage during the deployment period are graphed below (Figure 7). Stage was influenced by precipitation events.
- With the exception of water quantity data (stage), all data used in the preparation of the graphs and subsequent discussion below adhere to this stringent QA/QC protocol. Corrected data can be obtained upon request.

Conclusions

- An instrument was deployed at the Outflow of the Steady water quality monitoring station on August 14 and removed on November 26, 2020. This was the third and final deployment of the 2020 season.
- In most cases, weather related events or increases/decreases in water level explain parameter fluctuations.
- Water temperature decreased during the deployment period, ranging from 1.33 to 22.52°C. The data confirmed water temperature was corresponding with ambient air temperatures.
- PH values were all within the recommended CCME Guidelines for the Protection of Aquatic Life. pH ranged between 6.86 and 7.23. The brook is influenced by high precipitation events which decrease pH values for a short time.
- Specific conductivity ranged from 133.5 to 171.1 μ s/cm, showing a slight increasing trend during the deployment.
- Dissolved oxygen values were above the minimum CCME Guideline for the Protection of Other Life Stage Cold Water Biota of 6.5 mg/l. The majority of values were above the minimum CCME Guideline for the Protection of Early Life Stage Cold Water Biota value of 9.5 mg/l. The values below this guideline correspond to a rise in water temperature.
- Turbidity values of 1.2 NTU to 3.1 NTU indicated low background turbidity. Increasing turbidity corresponded to increases in the water level at this site.
- Stage was stable during this deployment period.
- With the exception of water quantity data (stage), all data used in the preparation of the graphs and subsequent discussion adhere to this stringent QA/QC protocol. Corrected data can be obtained upon request.
