The Minister of Municipal Affairs and Environment (the "Minister") hereby grants a non-exclusive water right to: **Cold Ocean Salmon Inc.** (the "Licensee") to use the water column and continue the operation of an existing freshwater aquaculture facility with an estimated area of 5.58 hectares in an Unnamed Pond, known as Long Pond, near Hermitage Road (47°35'37.2"N, 55°47'49.9"W), as indicated in Schedule A, in reference to the original application dated March 24, 1997, the application received on June 28, 2012, application received on September 3, 2013 for overwintering, application for an amendment received on July 15, 2015, Aquaculture Licence AQ15-LIC-1074 dated July 17, 2017, request to renew Water Use Licence received on November 30, 2017, and further information provided by the Department of Fisheries and Aquaculture, Fisheries and Land Resources, and Licensee on November 17, 2015, October 31, 2017, November 28, 2017, and December 18, 2017.

This Licence is subject to the terms and conditions, reservations, exceptions, and provisions stated herein and the *Water Resources Act* and regulations thereunder. Appendices A, B and Schedule A (attached) form part and parcel of this Licence.

This Licence does not release the Licensee from the obligation to obtain appropriate approvals, permits or licences from other concerned municipal, provincial and federal agencies.

The Licensee shall complete and return the attached Notification of Acceptance of Water Use Licence to the Water Rights, Investigations, and Modelling Section of the Department of Municipal Affairs and Environment within thirty (30) days of receipt of this Licence.

Failure to comply with the terms and conditions, reservations, exceptions, and provisions set out herein will render this Licence null and void, place the Licensee and/or its agents in violation of the *Water Resources Act*, and cause the Licensee to be responsible for any and all remedial measures which may be prescribed by the Department of Municipal Affairs and Environment.

APPENDIX A
TERMS AND CONDITIONS FOR WATER USE LICENCE

The Minister of Municipal Affairs and Environment (the "Minister") hereby grants a non-exclusive water right to: **Cold Ocean Salmon Inc.** (the "Licensee") to use the water column and continue the operation of an existing freshwater aquaculture facility with an estimated area of 5.58 hectares in an Unnamed Pond, known as Long Pond, near Hermitage Road (47°35'37.2"N, 55° 47'49.9"W), as indicated in Schedule A, in reference to the original application dated March 24, 1997, the application received on June 28, 2012, application received on September 3, 2013 for overwintering, application for an amendment received on July 15, 2015, Aquaculture Licence AQ15-LIC-1074 dated July 17, 2017, request to renew Water Use Licence received on November 30, 2017, and further information provided by the Department of Fisheries and Aquaculture, Fisheries and Land Resources, and Licensee on November 17, 2015, October 31, 2017, November 28, 2017, and December 18, 2017.

1. Ownership of water rights remains with the Crown and is not transferred. This Water Use Licence only provides permission for the Licensee to use water for the designated purpose indicated in this Licence.
2. The non-exclusive rights and privileges hereby demised by this Licence shall not be sold, assigned, transferred, leased, mortgaged, sublet or otherwise alienated by the Licensee.
3. The Licensee acknowledges and agrees that this Licence does not grant any interest in land or any right to expand the facility or to construct onshore facilities.
4. This Licence shall expire on December 20, 2022 or earlier if suspended or modified or cancelled by the Minister due to reasons that include, but is not limited to, non-compliance with the Water Resources Act, SNL 2002 c.W-4.01 and terms and conditions, reservations, exceptions, and provisions, lack of utilization of approved water for the designated purpose or prompt reporting pursuant to this Licence. Also, this Licence may be renewed by the Minister for such renewal term as the Minister deems appropriate, on such terms and conditions as the Minister considers appropriate and in the public interest, provided the Licensee/Holder applies for an extension at least hundred and eighty (180) days before the expiry of this Licence. This Licence supercedes and cancels WUL-15-8379.
5. This Licence shall remain in force and effect until such time as the Aquaculture Licence of the Licensee/Holder is not renewed by the Licensee/Holder or is cancelled by the Minister of Fisheries, Forestry and Agrifoods of the Province of Newfoundland and Labrador or his successor in office pursuant to the provisions of the Aquaculture Act, RSN 1990, c.A-13 and any regulations in effect thereunder from time to time and any other relevant legislation enacted by the Province of Newfoundland and Labrador in the future.
6. The designated purpose of the water use is Commercial/Freshwater Aquaculture
7. The Licensee shall not at any time impair, pollute or cause to be polluted the quality of water in Long Pond and any and all bodies of water flowing into and out of Long Pond or any nearby body of water. Also, this Licence shall not be interpreted as granting any rights to cause adverse effect(s) on water in or outside the area of the facility in Long Pond or other water user (s). The Water Resources Management Division of the Department of Municipal Affairs and Environment must be informed if this activity or any ongoing activity has a potential to impair water quality of Long Pond or any nearby body of water. In addition, any and all waste material that may result from this facility activities must be removed and disposed at a site approved by the regional Government Service Centre of the Department of Service NL. The Departments of Municipal Affairs and Environment and Service NL may require samples to be submitted for testing and analysis.
8. The Licensee shall secure the aquaculture gear by suitable anchors to prevent dislodgement due to wave action or other conditions and clearly mark the perimeter of the facility with cautionary buoys.
9. The Licensee shall keep all systems and works in good condition, and shall notify the Minister immediately if any problem arises which may adversely affect public safety and any/all water use. The Licensee shall be responsible for any environmental or property damage, or personal injury arising from dislodgement caused by wind, wave, or ice action, or structural failure or from other water related problems.
10. In the event that the site is no longer being used during the term created by this Licence, the Licensee shall remove the aquaculture gear and other work(s) and system(s) associated with and restore all areas affected by this facility to a state that resembles local natural conditions, further remedial measures to mitigate environmental impacts on water resources and all areas affected by this facility can and will be specified, if necessary in the opinion of this Department.

11. The Licensee agrees to be responsible for carrying out the terms and conditions of this Licence. The licensee agrees to abide by such further terms and conditions and directives as may be issued by the Minister of Municipal Affairs and Environment from time to time in relation to the site referenced in this Licence.
12. The total number of fish introduced into Long Pond in the month of November at the location of the cages approved by this Licence, shall not at any time exceed 700,000 during the term created by this Licence.
13. All fish that may be stocked at the approved site in Long Pond shall have an average weight of 130 grams and shall be removed out from Long Pond in the month of June at average weight of 150 grams.
14. This Licence is subject to the Water Use Charges Regulations, NLR 60/16 under the Water Resources Act, 2002 and the Licensee shall upon receipt of an invoice stating the amount owing for water use charges, pay to the Minister the full amount within thirty (30) days of the receipt of the said invoice and if imposed by provincial legislation, fees, incentives, royalties or subsidies for water use.
15. The Licensee shall sample the water of Long Pond four times during the term of this Licence, and provide water quality analysis reports for all parameters prescribed in the Certificate of Approval C.A. 98-02-4838. The Licensee shall also provide any other information that the Minister may require in whatever form, manner and time in relation to this Licence. In addition, the licensee shall annually inform, in writing, the Water Rights, Investigations, and Hydrologic Modelling Section of the Department of Municipal Affairs and Environment regarding any water related or environmental problems or other matters related to this Licence and compliance with its terms and conditions.
16. The Licensee shall operate the works and systems in a manner which does not cause any water related and/or environmental problems. The Licensee shall immediately notify the Minister if any problem arises which may adversely affect water or public safety or any and all water users.
17. The employees of the Department of Municipal Affairs and Environment, authorized by the Minister, may at all reasonable times during the term created by this Licence into the Licensee's facility and the Licensee's designated place(s) of business to inspect all associated systems or works, records, statements, and accounts, and shall be entitled to copy such information as may be required by the Minister in relation to this licence and may exercise all other powers of inspection as provided for in the Water Resources Act.
18. The Licensee and its agent(s), subcontractor(s), and consultant(s) indemnify and hold the Government and the Minister harmless against any and all liabilities, losses, claims, demands, damages or expenses including legal expenses of any nature whatsoever whether arising in tort, contract, statute, trust or otherwise resulting directly or indirectly from the non-exclusive rights granted under this Licence, the operation of the said facility and all associated systems or works, or any act or omission of the Licensee or its agent(s), subcontractor(s), or consultant(s) in or outside the said facility and all associated systems or works, or arising out of a breach or non-performance of any of the terms and conditions, and provisions of this Licence by the Licensee or its agent(s), subcontractor(s), or consultant(s).
19. If the Licensee or its agent(s), subcontractor(s), or consultant(s) fails to perform, fulfill, or observe any of the terms and conditions, or provision of this Licence Ministerial orders and guidelines, as determined by this Department, the Minister may, after providing ten (10) day notice to the Proponent, amend, modify, suspend, or cancel this Licence in accordance with the Water Resources Act.
20. Should any provision of this Licence be unenforceable, it shall be considered separate and severable from the remaining provisions of this Licence which shall remain in force and be binding as though the provision had not been included.
21. This Licence is subject to all provisions of the Water Resources Act, 2002 and any regulations in effect either at the date of this Licence or hereafter made pursuant thereto or any other relevant legislation enacted by the Province of Newfoundland and Labrador in the future.
22. This Licence shall be construed and interpreted in accordance with the laws of the Province of Newfoundland and Labrador.
23. This Licence/Permit shall be construed and interpreted in accordance with all applicable laws of the Province of Newfoundland and Labrador.

All notices to be given pursuant to the terms and conditions of this Licence shall be given in writing and delivered by facsimile with auto confirmation or registered mail. If a notice is delivered by facsimile, it is deemed to have been received on the day it was sent if that day is a normal business day, if not, it is deemed to have been received on the next normal business day. If a notice is sent by registered mail, it is deemed to have been received three days after the day it was mailed. The address of the Licensee is:

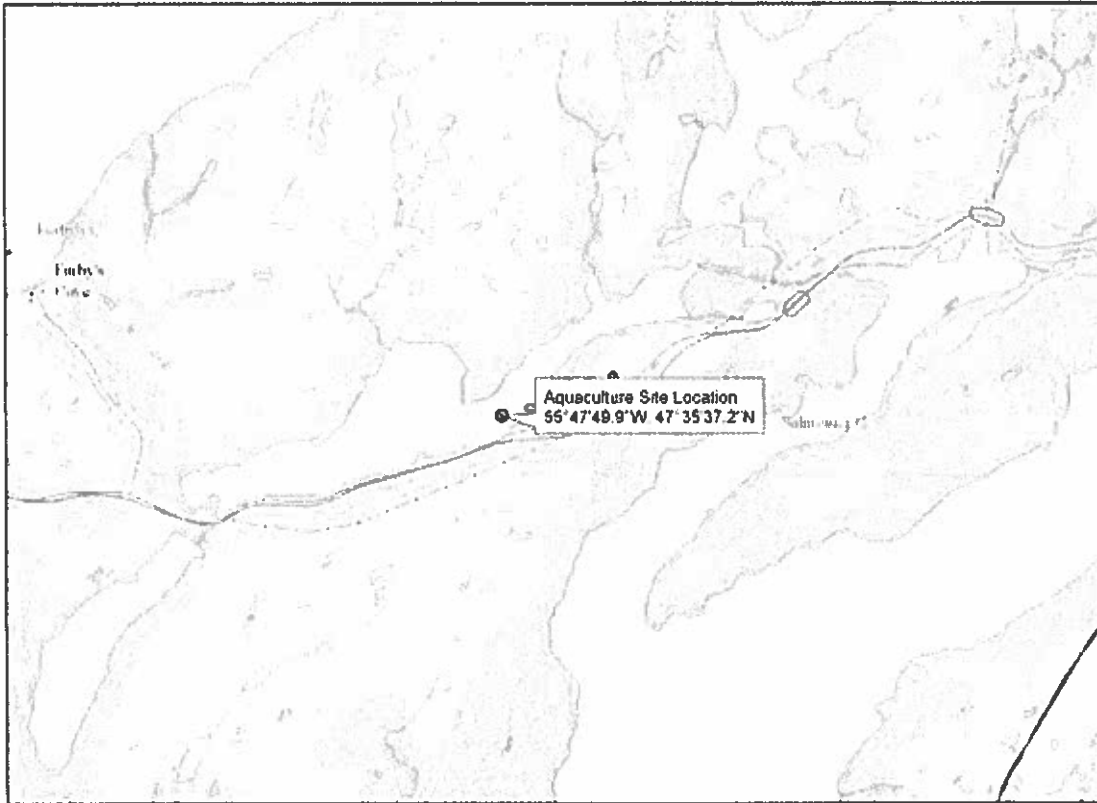
