#### **Environmental Assessment Bulletin**

The Honourable Tom Hedderson, Minister of Environment and Conservation, has announced the following events relative to Part 10 Environmental Assessment of the Environmental Protection Act.

### **UNDERTAKINGS REGISTERED:**

**Encanex Wastewater Treatment Operation** (Reg. 1679) **Proponent: Encanex Environmental Oil & Gas Corp.** 

The proponent has submitted a proposal to establish and operate a wastewater treatment facility at Pier 17 on the north side of St. John's Harbour. The proposed 5000 square foot existing infill site at Pier 17 is located on the harbour front just east of the existing MI SWACO site and south of the Battery Road and residential area. This facility will receive wastewater from offshore drilling operations that may contain total petroleum hydrocarbons, total suspended solids, solids (90 per cent > 50 microns), metals typically associated with hydrocarbons, and free oil. The wastewater will be received from ship via piping on the existing infrastructure. Wastewater will be treated at a maximum rate of 50 gallons per minute and discharge water will meet Schedule A or B of the Newfoundland and Labrador Treatment Control Water and Sewer Regulations. With the necessary permits in place, treated water within these schedules will be released to storm or sanitary sewer. The proposed facility will provide up to five new jobs and treatment operations are scheduled to commence as early as January 1, 2013.

The undertaking was registered on November 1, 2012; the deadline for public comments is December 7, 2012; and the minister's decision is due by December 16, 2012.

Crown District 19A Five-Year Operating Plan (2013 – 2017)

Proponent: Department of Natural Resources (Reg. 1678)

The proponent has submitted a Five-Year Operating Plan for Forest Management District 19A. This district is approximately 2.27 million hectares of boreal forest situated in the area of Upper Lake Melville, Labrador. Forest Management Area (FMA) 19A is one of three subdivisions of FMA 19 in Central Labrador. FMA 19 is generally bounded to the north by the Mulligan and Red Wine Rivers, to the east by the height of land that separates the Kenamu River watershed from those flowing into the Labrador Sea, to the south by the height of land that separates the Gulf Watershed from those flowing into the Labrador Sea, and to the west by a line at longitude 61° 45′. The proposed project will mainly involve harvesting, silviculture and road construction. Approximately 200,000 cubic metres of commercial timber is scheduled to be harvested and a total of 61 kilometres of primary access road to be constructed as a part of the operating plan.

The undertaking was registered on November 1, 2012; the deadline for public comments is December 7, 2012; and the minister's decision is due by December 16, 2012.

# Crown Districts 9 & 16 (Jackson's Arm) Five-Year Plan Amendment Proponent: Department of Natural Resources (Reg. 1677)

The Department of Natural Resources has proposed an amendment to the current Crown Five-Year Operating Plan for Forestry Management Districts 9 and 16 near Jackson's Arm. Local residents have requested an alternate domestic harvesting area due to increased difficulty accessing existing domestic harvest areas. Proposed harvesting will consist of domestic sawlog and firewood operations using chainsaws and extraction with snowmobiles. The estimated annual harvest will be approximately 400 cubic metres per year, with approximately twenty permits issued to local residents each year.

The undertaking was registered on October 29, 2012; the deadline for public comments is December 7, 2012; and the minister's decision is due by December 13, 2012.

Labrador – Island Transmission Link Proponent: Nalcor Energy

(Reg. 1407)

Following public, Aboriginal and governmental review, the Species of Special Conservation Concern Component Study, submitted on November 16, 2011, is acceptable.

## **UNDERTAKING RELEASED:**

Bellevue Golf Course (Reg. 1663)

**Proponent: L'Mariedo Enterprises Limited** 

The project is released from further environmental assessment review subject to the following conditions:

- 1. With the exception of the access road, the proposed golf course must not be located within the protected public water supply area for the Local Service District of Bellevue.
- 2. The proponent must maintain a minimum 100-metre buffer from the former public water supply well (unless the well has been properly sealed and decommissioned) in order to protect the groundwater quality in this well and any adjacent wells.
- 3. A <u>minimum</u> 50-metre naturally vegetated buffer must be maintained along all waterbodies and wetlands to protect sensitive species and their habitat. This buffer must be strictly adhered to for tees, greens and fairways.
- 4. The proponent must survey the area for eagles and osprey, if any nests are found in the area, an 800-metre construction activity buffer is recommended during the nesting and brood rearing periods (May to mid-July) which can be reduced to 200 metres during all other times of the year.
- 5. Certification of the course under the <u>Audubon Cooperative Sanctuary Program for Golf Courses</u> must be achieved within three years from the start of construction. This Department must be notified of when this certification is obtained.
- 6. An Environmental Protection Plan (EPP) shall be prepared by the proponent and approved by the Minister of Environment and Conservation prior to the start of construction.
- 7. The golf course shall be designed such that its layout and operation will not interfere or otherwise conflict with adjacent residents or land use. A certificate of compliance, completed by a qualified professional, shall be submitted to the Department of Environment and Conservation for approval prior to the start of construction.
