Environmental Assessment Bulletin

The Honourable Andrew Parsons, Minister of Municipal Affairs and Environment, has announced the following events relative to Part 10 Environmental Assessment of the Environmental Protection Act.

UNDERTAKINGS REGISTERED:

Foxtrap Access Road - TCH Junction Quarry(Reg. 1964)Proponent: Platinum Construction Company Limited(Reg. 1964)

The proponent plans to construct and operate a 25.3 hectare rock quarry at the junction of the Trans-Canada Highway and the Foxtrap Access Road within the City of St. John's development area. An access road is planned from Incinerator Road to the west side of the quarry. Construction will include building the access road and stripping the terrain to access the underlying rock. The operation will include drilling, blasting, crushing, and stockpiling. The processed aggregate will be provided to local interests. Reclamation will be determined by the requirements of a quarry permit or lease.

The undertaking was registered on May 28, 2018; the deadline for public comments is July 2, 2018; and the minister's decision is due by July 12, 2018.

Deer Lake Underwater Log Survey Proponent: Town of Deer Lake

The Town of Deer Lake proposes to assess the quantity and quality of sunken pulp wood logs at the bottom of Deer Lake by conducting a survey using side-scan sonar technology. It is expected that logs have accumulated from over 60 years of logging operations on the Humber River. The results of the survey will be used to determine the feasibility of recovering logs for use in manufacturing specialty products such as flooring and furniture.

The undertaking was registered on May 28, 2018; the deadline for public comments is July 2, 2018; and the minister's decision is due by July 12, 2018.

Glenburnie Drydock Proponent: 3 T's Limited

The proponent proposes to construct a 2,090 square metre dry dock at Glenburnie in Bonne Bay, Western Newfoundland. The dry dock will extend 76.2 metres out from the highwater mark and will be 27.4 metres wide. The structure will consist of a 15.2 metre wide concrete slipway bordered by two piers each with a 0.3 metre wide inner wall and a 5.8 metre band of armour stone.
