## **Environmental Assessment Bulletin**

The Honourable Andrew Parsons, Minister of Municipal Affairs and Environment, has announced the following events relative to Part 10 Environmental Assessment of the Environmental Protection Act.

### **UNDERTAKING REGISTERED:**

**Mary's Harbour Breakwater** (Reg. 1983)  
**Proponent: Fisheries and Oceans Canada, Small Craft Harbours Branch**

The proposed project is for the construction of a rubble mound breakwater. The breakwater will measure approximately 165 meters in length and the width will vary between approximately 10 and 30 meters. The breakwater is required to dissipate wave action in the harbour before it reaches the existing harbour infrastructure. Construction of the breakwater is expected to require 14 weeks to complete.

The undertaking was registered on September 12, 2018; the deadline for public comments is October 19, 2018; and the minister's decision is due by October 27, 2018.

### **ENVIRONMENTAL IMPACT STATEMENT REQUIRED:**

**Hope Brook Access Road** (Reg. 1968)  
**Proponent: First Mining Gold Corporation**

The minister has advised the proponent that an environmental impact statement (EIS) is required for this project. Additional project and baseline information requirements will have to address, but are not limited to: project scope including rationale for the project and type of road, effects on wildlife and related habitat (including wetlands), and effects on outfitters. An environmental assessment committee will be appointed to provide scientific and technical advice to the minister and to prepare draft guidelines for conducting the EIS. The public will be invited to provide comment on the draft guidelines.
