Environmental Assessment Bulletin

The Honourable Andrew Parsons, Minister of Municipal Affairs and Environment, has announced the following events relative to Part 10 Environmental Assessment of the Environmental Protection Act.

UNDERTAKING REGISTERED:

Crown Zone 6 Five-Year Forestry Operating Plan (2019-23) (Reg. 1984) Proponent: Department of Fisheries and Land Resources

The proponent has submitted a proposal for a Five-Year Operating Plan for Zone 6 which includes Forest Management District 14 and 15 located on the Southwestern extent of Newfoundland. The undertaking will enable the harvesting of 152,900 cubic metres of timber, construct approximately 32 kilometres of resource access road, and apply silviculture prescriptions throughout the zone within the five year period. The undertaking is necessary to maintain the existing commercial industry and allow domestic harvest for home heating. The plan covers the period from January 1, 2019, to December 31, 2023.

The undertaking was registered on September 19, 2018; the deadline for public comments is October 26, 2018; and the minister's decision is due by November 3, 2018.

ENVIRONMENTAL PREVIEW REPORT SUBMITTED:

Ming's Bight (Argyle) Gold Mine Proponent: Anaconda Mining Inc.

(Reg. 1959)

Lark Harbour Multipurpose Trail Extension

An Environmental Assessment Committee has been appointed to provide scientific and technical advice to the minister and to prepare draft guidelines for conducting the EPR. The Environmental Assessment Committee includes representation from the following provincial and federal government agencies:

UNDERTAKING RELEASED:

Goobies EWS Nursery and Laydown Area (Reg. 1973)

Proponent: EWS - Engineered Wetland Solutions Ltd.

The project is released subject to the following conditions:

- The proponent is encouraged to primarily use native species for stocking the nursery. Prior to construction, the proponent must consult with the Forestry and Wildlife Branch to obtain a list of native species and examine the potential to use these species in both engineered wetlands and restoration projects.
- If the common reed *Phragmites australis* subsp. *americanus* is to be used in engineered wetlands, a Containment Plan must be submitted to, and approved by, Forestry and Wildlife Branch prior to wetland planting. The plan will describe

measures to contain non-native plants to the nursery site and any sites where the plants will be established; as well as monitoring of those sites to ensure there are no escapes into natural ecosystems. Please contact the Forestry and Wildlife Branch at (709) 637-2423.

- Only native species are to be used in any wetland restoration activities.
- The Eurasian subspecies of the common reed (*Phragmites australis* subsp. *australis*) is not to be imported, propagated or otherwise utilized within nursery operations, wetland restoration or engineered wetland facilities.
- The proponent must maintain a minimum 30-metre naturally vegetated buffer along all watercourses, waterbodies, and wetlands to protect sensitive riparian and aquatic species and their habitat.
