Construction of snowmobile trail from Southern Head, Little Burnt Bay to Lewisporte to connect with the Notre Dame snowmobile trail

THE UNDERTAKING:

- (I) Nature of the Undertaking: The cutting of a trail from Southern Head, Little Burnt Bay to Lewisporte to connect with the Notre Dame Snowmobile Trail at Lewisporte
- (ii) Purpose/Rationale/Need for the Undertaking: The residents of Little Burnt Bay & Embree have formed a Snowmobile Trail Committee in order to construct and connect with the Notre Dame and thus the Newfoundland & Labrador Snowmobile Trail. This Snowmobile Trail has to be cut through wooded area from Little Burnt Bay to Lewisporte. The Towns of Little Burnt Bay, Embree & Lewisporte fully supports this endeavor as it will enhance the Trail system as a whole and will not only give to the residents of Little Burnt Bay & Embree access to the bigger Trail system but also give access to the Newfoundland and Labrador Trail system access to another beautiful part of our landscape and no doubt will boost revenue to local businesses

DESCRIPTION OF THE UNDERTAKING:

- (I) Geographical Location: From Southern Head, Little Burnt Bay through to Lewisporte, through the town boundaries of Little Burnt Bay, Embree and Lewisporte
- (ii) Physical Features: Approximately 15 km of snowmobile trail. This trail passes outside the 150 metre buffer zone around Trokes Cove Pond Protected Water Supply Area (used by the towns of Little Burnt Bay and Embree) *Permit No: 03-106 already issued*
- (iii) Construction: Approximately 8 weeks for cutting of trail
- (iv) Operation: This permanent trail will be used as a snowmobile trail in the winter months and possibly as a summer hiking trail
- (v)Occupations: The Notre Dame Snowmobile Trail Committee has agreed to groom the trail to Little Burnt Bay, thus the only occupation will be the already groomer operator
- (vi) Project Related Documents: Application was made in the summer of 2003 to the Govt. Service Center Gander thus going to Crown Lands, Forestry & Water Resources. Permit for Development Activity has been issued pursuant to the Water Resources Act, Permit No: 03-106

APPROVAL OF THE UNDERTAKING:

Permits are required from the following - Crown Lands, Forestry, Water Resources and Department of Environment. Also authorization from the Towns of Little Burnt Bay, Embree and Lewisporte

SCHEDULE:

Plans are to commence construction as soon as all approvals are in place, hopes are to have this trail completed for use this coming snow season

FUNDING:

Application has been made to HRDC at Gander for funding to cover the cost of employing persons to cut the trail. Approximate cost of this undertaking is \$20,000.00
