# The Undertaking:

(i) Nature of undertaking:

Campground Expansion

(ii) Purpose/Rationale/need for the undertaking:

Presently, I have 40 Camp Sites. In the peek Tourist Season the demand is much greater. Also, there is a growing interest in Tent Cabins. The present trail to Lomond River has in the past been used as a fishing trail but, needs to be upgraded to make it more appealing for hiking and sight seeing.

# **Description of Undertaking:**

(i) Geographical Location:

I am proposing expanding my campground to include 10 Fully Serviced Sites, 10 Fully Serviced Drive through Sites, 10 Tent Cabin Sites and Trail to Lomond River. Also, future plans for cottage development, depending on demand. This expansion will be located adjacent to my existing business Lomond River Lodge on Route 431, Lomond River. The proposed site will be bordering Gros Morne National Park to the North, Lomond River to the East, Lomond River Lodge to the South and Route 431 to the West.

(ii) Physical Features:

Refer to the hand-drawn layout for the area involved in the expansion:

A Comfort Station and Tent Cabins will be the only buildings. Roads will be constructed for access and no water courses will be crossed. Has to, the exact location and length of the road that remains to be determined. Also, the location and type of construction for sewer system hasn't been determined, but, will comply with the necessary government regulations and standards, before construction commences. Upgrading of the existing fishing trail will be for hiking only, ATV's will not be permitted. We will remove any obstructions in the trail(like fallen trees)

and install board walk or crushed stone over wet areas. Also, have viewing and rest areas along the trail with picnic tables and garbage cans. No trees or natural areas will be disturbed.

## (iii) Construction:

Planed construction to be phased in over the next five years. Starting this summer with the landscaping and gradually adding the sites over the next four years or sooner, as finances permits.

We do not expect any potential sources of pollutants during construction or any cause of resourse conflicts.

#### (iv) Operation:

This will be an addition to our present tourist business. Operating seasonally from May 15 - Oct. 15. We do not anticipate any potential sources of pollutants during the operating period. We strive to make our business an environmentally friendly operating.

#### (v) Occupation:

Carpenters and Laborers will be required to complete this undertaking. Carpentry and brush cutting tools will be used. At this time we do not anticipate hiring extra workers, most of this work will be carried out by our regular summer staff. We have a certified Occupational Health and Safety Representive and Policy on site and all workers will comply with the Occupational Health and Safety Regulation.
