THE UNDERTAKING:

(i) Nature of the Undertaking: Fortune Recreation (ATV) Trail

(ii) Purpose/Rationale/Need for the Undertaking: Construction of a 12 km.
ATV trail for access to
remote cottage.

DESCRIPTION OF THE UNDERTAKING:

- (i) Geographical Location: See attached map, "Exhibit A". Access to cabin obtained from the Fortune Arena (approximately 12 km from Fortune Arena to remote cottage).
- (ii) Physical Features: Said trail as indicated on the map provided (Exhibit A) will be 10' - 12' wide the full length of the trail which is approximately 12 km.
- (iii) Construction: Construction is planned as soon as permit is issued.
An excavator will be used to go to the top of the Hill approximately 1km on pre-existing trail. The rest of the trail will be completed by hand using chainsaw, hand tools, etc.
- (iv) Operation: This ATV trail will provide all year round access to the remote cabin.
- (v) Occupations: The trail in question would be used by the public.
- (vi) Project-Related Documents: The Association will require a Crown Land Permit (File Ref. No. 200.20.1317, Application No. 1026163 - Permission to occupy ATV trail).
