| Transmission Fluid | - | is also disposed of in a quality drum and also picked up from “an approved company” <b><u>Pardy Tire of Corner Brook.</u></b>  |
| Antifreeze         | - | is recycled in company vehicles.   |

When the used cards are inspected and ready for recycling, the following steps are completed.

1. Cars are disassembled for recycling.
2. All parts that are in good working condition will be kept for sale.
3. The remainder of the vehicle will be shored until the car crusher takes over and crushes the vehicles.
