The Undertaking

Nature of undertaking

To maintain existing road system for snowmobile trial to access NLSF primary trail.

Purpose/Rational/Need for Undertaking:

Maintain snowmobile trail from the old Bonavista North Highway and surrounding areas to access the NFSL trail during the winter season, while avoiding any waterways and promote safe snowmobiling.

Description of the undertaking:

Geographical Location

Construction
