The two maps are of different scales, so it is difficult to say for sure, but it appears as though the boundaries of Proposed Waste Management Facility Site #2 do slightly overlap the boundaries of the area proposed by the LSD of Norris Arm North. Of course, this boundary at the lower end of the watershed is arbitrary at this point in time, depending upon where the intake is proposed. Therefore, I think that given a choice, I would recommend site 1 over site 2.

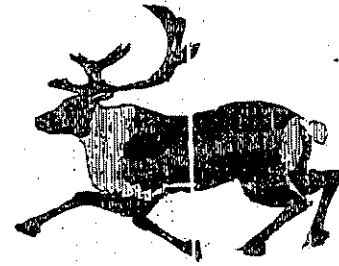

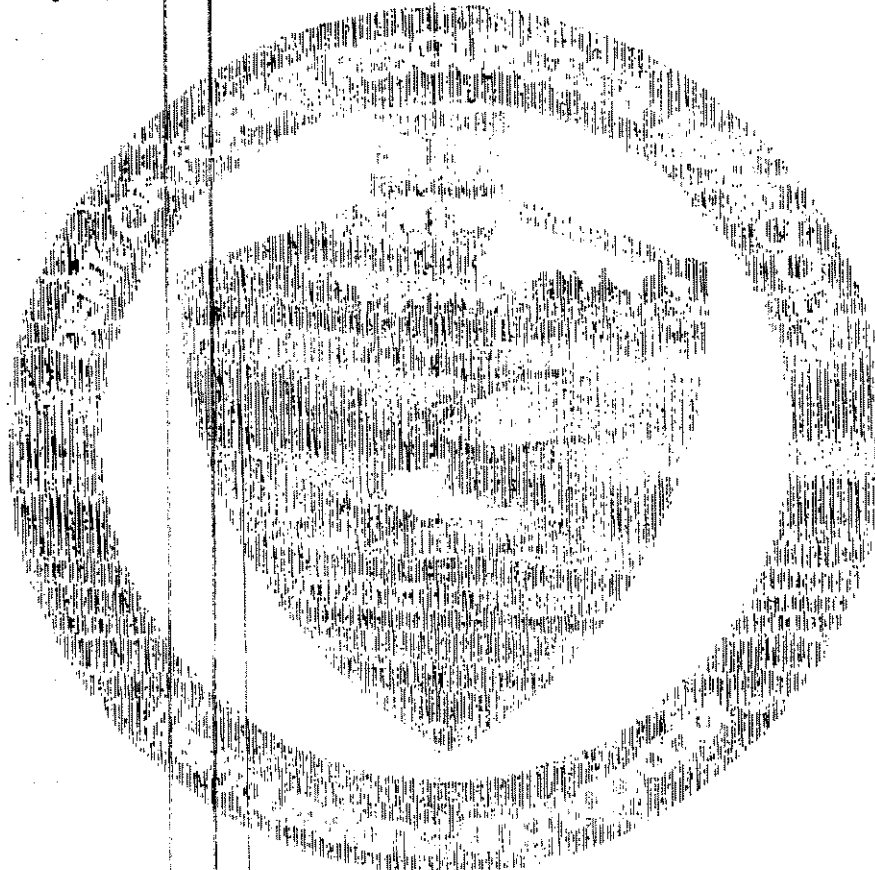

RE: Central Newfoundland Waste Management Study - Site Selection

Thank you for the opportunity to comment on the site selection for the proposed Central Newfoundland waste management facility. There were no concerns identified for either site from an Agrifoods perspective.

From a forestry perspective, however, both sites contain merchantable timber, therefore, if either of these sites are chosen forest harvesting should be allocated to existing commercial operators in the district. Both areas are within domestic cutting zones and the area chosen would result in an equivalent loss to the domestic cutters. There is also a small plantation (see attachment) bordering the larger of the sites, therefore, this area should be excluded from the proposal.

Approximately one half of the larger proposed site contains timber licensed to Corner Wood Pulp and Paper (see attachment). The company should be contacted concerning this proposal.

Both sites would result in the removal of productive forest from domestic use which further aggravates the provincial wood supply shortage. It is understood, based on other regional waste management initiatives, the site selection policy is to minimize any impacts, therefore, we would be interested to know if there are other suitable potential sites that would have less impact on forestry.

We would be interested in receiving information about the Central waste management  
perspective concerning the proposed operation and from a policy and planning perspective.
