Marystown-Burin Area Chamber of Commerce strongly supports and endorses your efforts to extend the Frenchman's Cove Grande Meadows Golf Course from nine (9) holes to (18) holes.

The Marystown-Burin Area Chamber of Commerce, specifically representing business, is a member of a structure that involves local, provincial, Atlantic and Canadian chambers. The fifteen (15) member board of directors represents the businesses of this area but because the Burin Peninsula identity lies within the whole peninsula and not within one specific community there is a natural tendency for the chamber to be cognizant of the Burin Peninsula business community.
