THE UNDERTAKING:

- (i) Nature of the Undertaking: To extend the John Hogan Trail 2 kms.
- (ii) Purpose/Rationale/Need for the Undertaking: To open up access at least 3 more salmon pools. This will help to drive tourism in the area by allowing angling access to more pools.

DESCRIPTION OF THE UNDERTAKING:

- (i) Geographical Location: The trail will extend along the edge of the Torrent River. See attached map.
- (ii) Physical Features: There are no major physical features of the undertaking. The physical environment within the area includes dead shrub/trees that will be removed.
- (iii) Construction: The approximate construction period will be 20 weeks. The proposed date of physical construction on the site is July 15, 2010. There will be no pollutants onsite during the construction.
- (iv) Operation: The trail will extend along the edge of the Torrent River. It will take approximately 20 weeks to complete this project from start to finish. There will be no pollutants during the operation period of this project.
- (v) Occupations: There will be 10 labourers hired for 20 weeks to fully complete the constructions period and the operational period. These people will be hired through a Job Creation Project under Department of Human Resources, Labour and Employment. Employment equity will be address by hiring people between the ages of 25-40, both males and females.
- (vi) Project Related Documents: Approvals to date: Crown Land Permit and Dept of Fisheries and Oceans.

SCHEDULE:

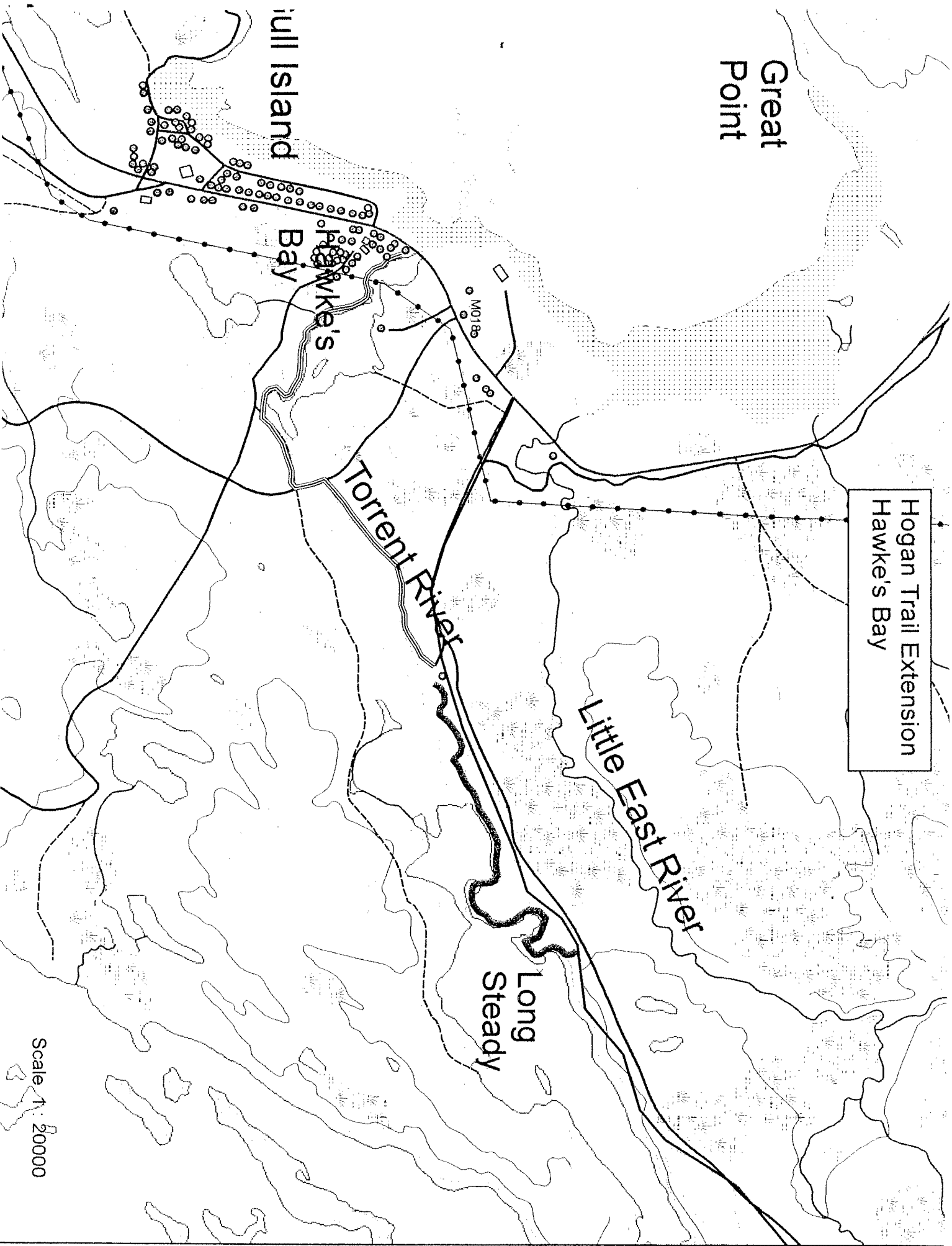
Project construction will commence July 15, 2010. This is due to the available manpower and due to the time of the year. We will be able to access the area required to complete the work.
