3. THE UNDERTAKING

(1) Nature of the Undertaking

Development of a Municipal Park at First Pond, Forteau

(2) Purpose/Rationale/Need For The Undertaking

To develop an area where local residents and tourists can camp overnight or a place where families can go for a daytime outing. Presently there is no area designated for this purpose.

To provide an opportunity for the development of tourism in the Forteau area.

4. DESCRIPTION OF THE UNDERTAKING

(1) **Geographic Location**

First Pond is located approximately at 51 29' 56.32" North and 56 57' 59.64" West It is within the municipality of Forteau and about 3 kms from the town proper.

(2) **Physical Features**

- The area of development will face unto a sandy beach of the pond
- Presently the beach is used as a swimming area and storage location for boats that cross first pond to enable fishermen to have access to the various salmon pools.

(3) **Construction**

- Construction expected to require a 5 week period
- Proposed start up date is early summer 2011
- no potential resources conflict
- no potential pollutants. Work will be completed using manual tools such as hammer, handsaw, shovel, picks, etc. Trucks may be used to bring gravel and/or crushed stone to the area
- axes and chainsaws may be used to clear some of the brush
- picnic tables
- portapotties located as needed

(4) **Operations**

- several camping areas will be created
- a parking area will be designated that can accommodate trailers and campers
- some fire pits will be strategically located
- picnic tables will be provided for park users
- garbage disposal bins will be placed throughout the campground

(5) **Occupation**

- The project is expected to employ two people

5. APPROVAL OF THE UNDERTAKING

A Crown Lands Application has been submitted to the Dept. Of Environment and Conservation in Goose Bay requesting a licence to occupy the land on which the proposed municipal park will be constructed.
