The Undertaking:

The undertaking involves an amendment to an existing licence (#110126, File # 1/20705-0) for a 5 kilometre ATV trail from Route 210 to Fall Pond that was issued in 1997 (see attached map). The amendment will add approximately 2.5 kilometres to the original trail to allow another access point along Old Mill Road, near the intersection with Route 210, near Swift Current. The trail will be approximately 3-3.5 metres in width. This trail would be used year-round by snowmobile and by ATV.

Environment Description:

The terrain consists of mostly rolling barren ridges with scrub underbrush. Some areas are very rocky while others are small boggy areas. There are a couple of areas where some trees would have to be cut. There are 2 brooks along the route as well.

Construction:

The trail would be constructed to protect wetlands, streams and not to interfere with wildlife. Any bridges constructed would be done with non-treated material. Bogs would be corduroyed if necessary. Construction would be done by manual labor and excavator and during the summer and fall. Potential causes of pollutants would be oil or fuel leaks from the excavator. There are no conflicts expected during construction as there are no other occupants in the area. Once the trail is constructed it would be used year-round mostly during weekends. This would provide safe cabin access on a marked trail that is kept up to standards.

Approval of the Undertaking:

The proponent will require a Crown Land Application (amendment to licence #110126) for this trail.

Schedule:

Work would begin once permits are in place and during a suitable time /seasonally.

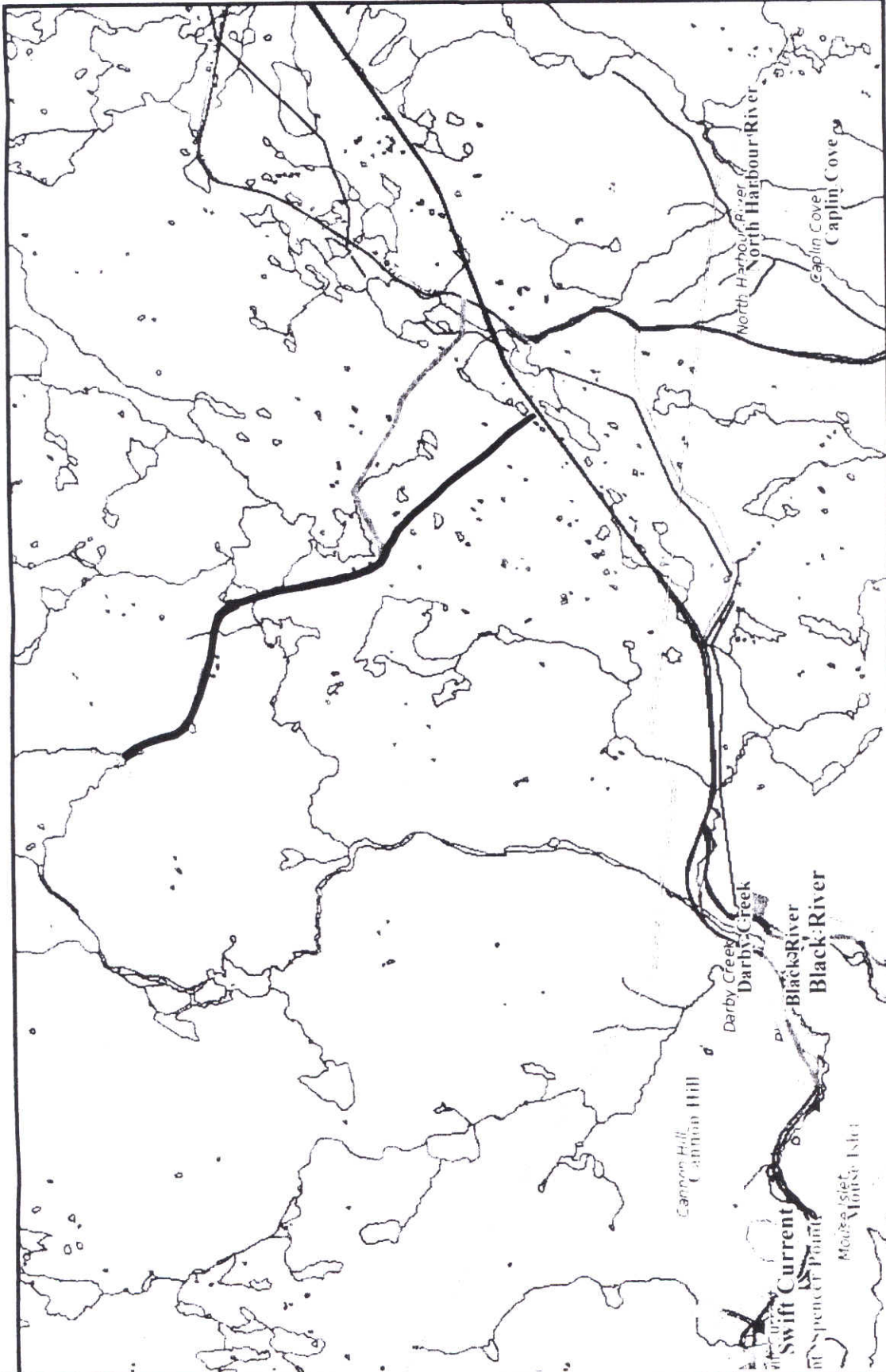
Funding:

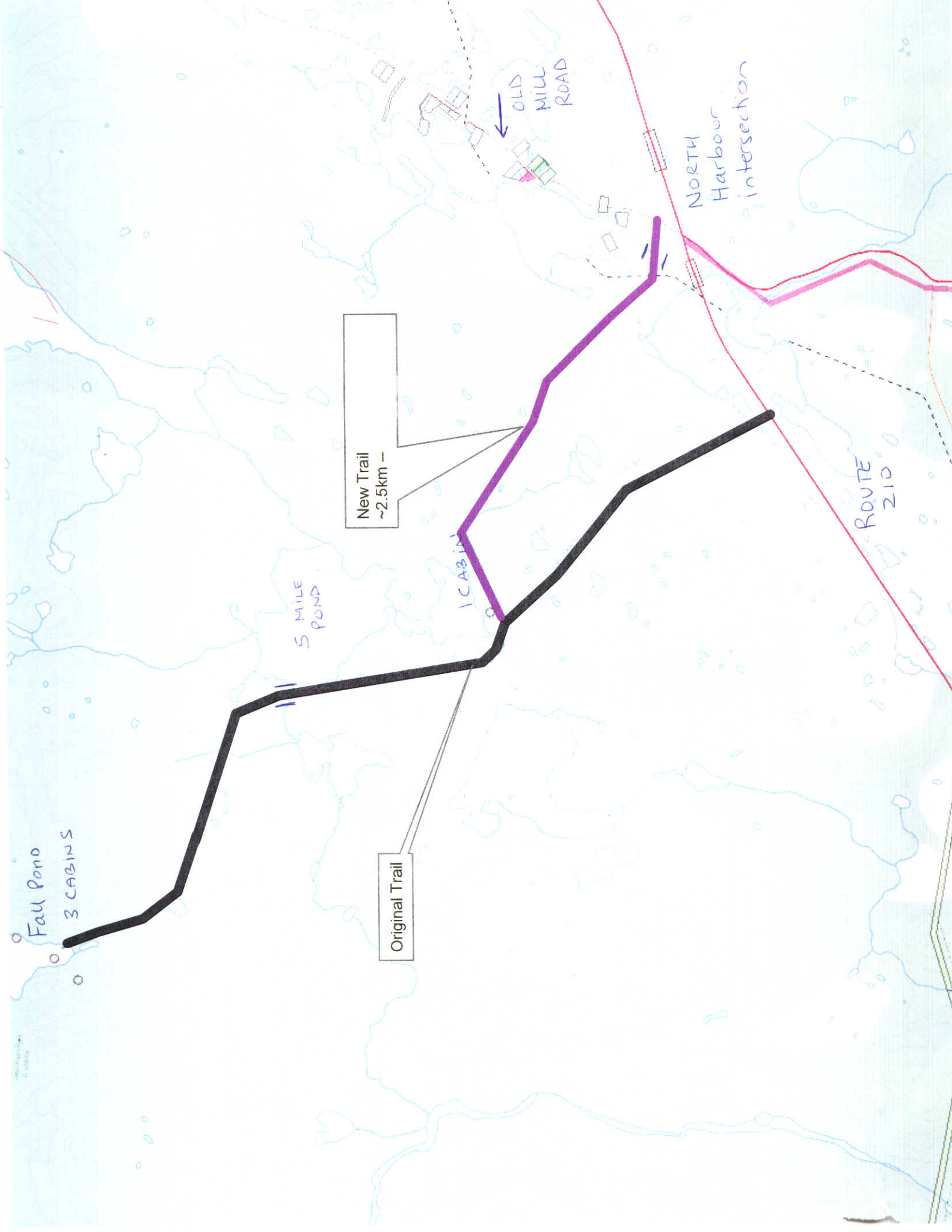
