The Undertaking

The undertaking our old trail was alas destroyed by Igor storm beyond upgrading. Extension is about 3 km from the highway to Hodges Cove ATV Trail making it one ATV and Snowmobiling Trail. The Trail from Little Hearts Ease to Deer Harbour is also used by Hikers and Cross Country Skiing.

Description of Undertaking

The Geographical location of the trail extension will begin on the West side of the main Highway entering Little Hearts Ease.

The Trail will require one Bridge, a small brook running from Pie Pond, know as our swimming pond for 100 years +. Building one Bridge six feet wide with pressure treated 6x6 square lumbers.

In 1949, the people of Little Hearts Ease had a horse wood winter trail in the same area; this was done under the first U.I.C program in Newfoundland.

The proponent of undertaking will require a Permit to Occupy the Extension.

Funding


All funding will be the responsibility of the Trail Associations membership fees fundraising.


