

NAME OF UNDERTAKING: ATV Trail to Third Pond on Great Northern Peninsula

THE UNDERTAKING:

- i) Nature of Undertaking: construction of an ATV trail
- ii) Purpose: To construct an ATV trail to an existing cabin located at Third Pond

DESCRIPTION OF THE UNDERTAKING:

i) Geographical Location:

The proposed ATV trail will begin at the end of an existing forestry access road, follow an existing lumber jack trail for approximately 1km and continue for another 1km to an existing cabin located near Third Pond. The approximate location of the proposed ATV Trail is shown on the attached Google Earth image and 1:50,000 topographic mapping (see figures 1 and 2).

ii) Physical Features:

The proposed ATV trail will measure approximately 2.0km. The trail will be located on solid ground and will avoid all water bodies and wetlands. The proposed route will follow an existing grown in lumber jack trail for approximately 1km (see attached photo) and then 1.0km along dry ground through trees, many of which have been blown down from a recent wind storm in 2011. There will be no negative impacts on the existing environment.

iii) Construction:

The ATV trail will be constructed by clearing trees and removing stumps. It is expected that the trail will be constructed in a period of 1 week or less. The trees will be cleared using chain saw. The stumps will be removed using a bobcat or small excavator.

iv) Operation:

The ATV trail will be constructed and maintained by the proponent to allow access to existing cabin on a long term basis.

v) Occupations:

The clearing of trees will be completed by the proponent while a local contractor will be hired to remove any tree stumps.

vi) Project- Related Documents:
Not applicable.

APPROVAL OF THE UNDERTAKING:

A Licence to Occupy may be required from Crown Lands.

SCHEDULE:

The ATV trail will be constructed in the fall of 2012 if all permits and approvals are in place. Otherwise the project will be completed in spring 2013.

FUNDING:

This project does not depend on any grant or loan of capital funds. The cost of the project is less than \$10,000.

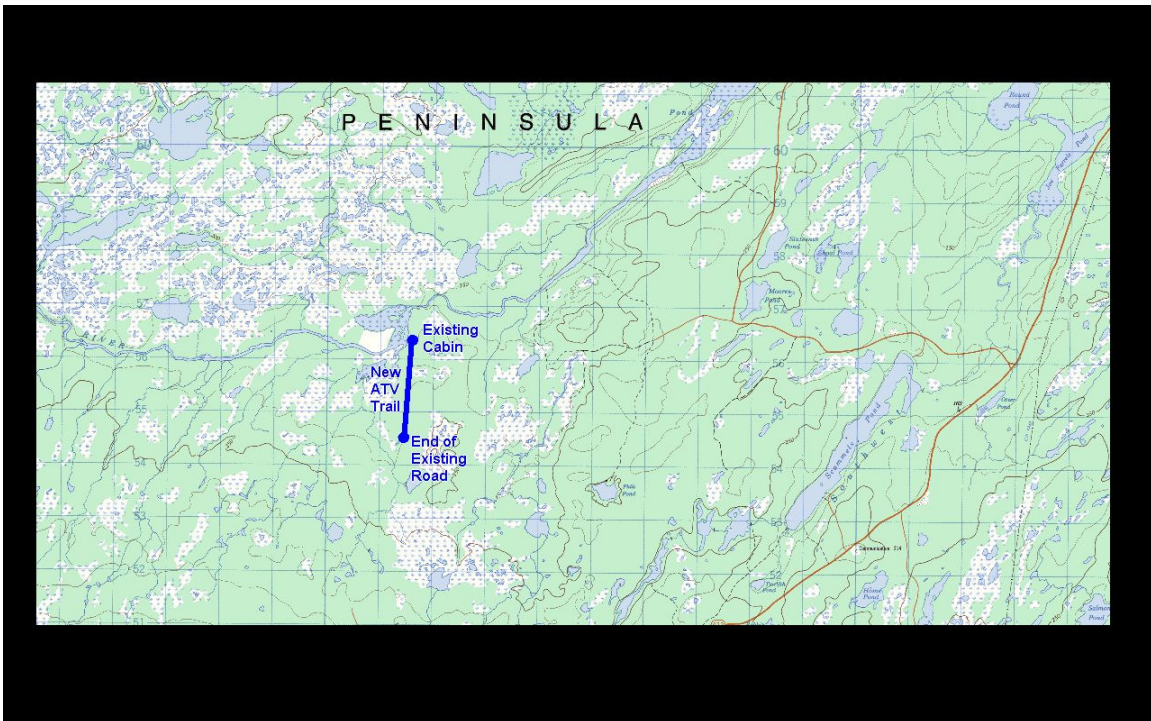
