We are asking to register a project of constructing an access road between Sail Pond and Coles Pond, Roddickton, NL. As such we submit to you this draft with the following information:

The Undertaking: Construct an access road between Sail Pond and Coles Pond. The purpose of this road is to make access by vehicle to our Youth Camp site. In the past it has been accessed by boat through the waters of Coles Pond. The road would provide a safer way to transport some 120 people during our week of Youth Camp activities.

Description of the Undertaking: As stated above we have used boats over the past years to transport campers to our camp site. We do feel that having the site connected by road, would be a more safer and convenient way. The proposed access road would be taken off from Sail Pond Road go NNE to Coles Pond (within 500 feet of the Pond). See <u>map</u> 1 and <u>map</u> 2.

Physical Features of Construction: The proposed road route (which is possibly less than a mile) connects with very little forest. We would engage a contractor to build the road. If the foundation of the road could start by December 1, 2012 it would have a period to settle over the winter months. We would complete the road and the bridge in the spring (not later than June 1st) giving us time to access the site and prepare for the 2013 annual Youth Camp. The road route has been selected by local forestry officials, which follows a previously forested area. It would be built as a single lane road with passing sections every 200-300 feet.

This access road over the long term would have no or a small impact on the water ways and associated fish populations.

Actually, we do not anticipate any impact on fish, wildlife or rare plants. It would have a much safer and more sustainable means to access the camp site. It would give us more of a social value for the camp and take away much of the present logistical burden in trying to transfer all of those children safely. By taking the two boats we now have (operated by gas motors) from the pond would also reduce the pollution factor at Coles Pond.

This less than one mile propose road is marginal compared to the total of all the other access roads in that area.

The route of the road takes us over one small brook (stream) which flows into Coles Pond. We are proposing to use wood beams to cross the brook and wood material to cover the bridge. It would be 8-10 feet long and 12 feet wide.

The design of the bridge will replicate the forestry bridges in that area. We will try and utilize the trees cut for the right-a-way and use for the bridge construction, minimizing the forestry impact. About 75% of the proposed route has few or no trees to cut. Most trees are north of the stream, near the camp site.

For the construction cost there is no grant or loan involved. We will fund the cost ourselves.

Taking into consideration the time of the season, we appreciate your earliest attention and response.


