**(2) PHYSICAL FEATURES:**

The undertaking will be to remove materials for construction work in the Cow Head area. The material will be removed by Front end loader and Tadem axle dump truck. The road have already been established. The area have been clear cut and pit operations have been ongoing here for a number of years. It is adjacent to pit operated by Paul Parsons, Newfoundland & Labrador Hydro Inc. and Pittmans, Operation will not be visible from Route 430. No Blasting, screening or washing activities will take place.

- The size of the area is 4.5 hectares.
- Attached is an aerial photograph of site.

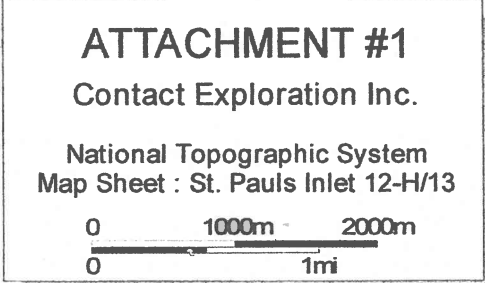

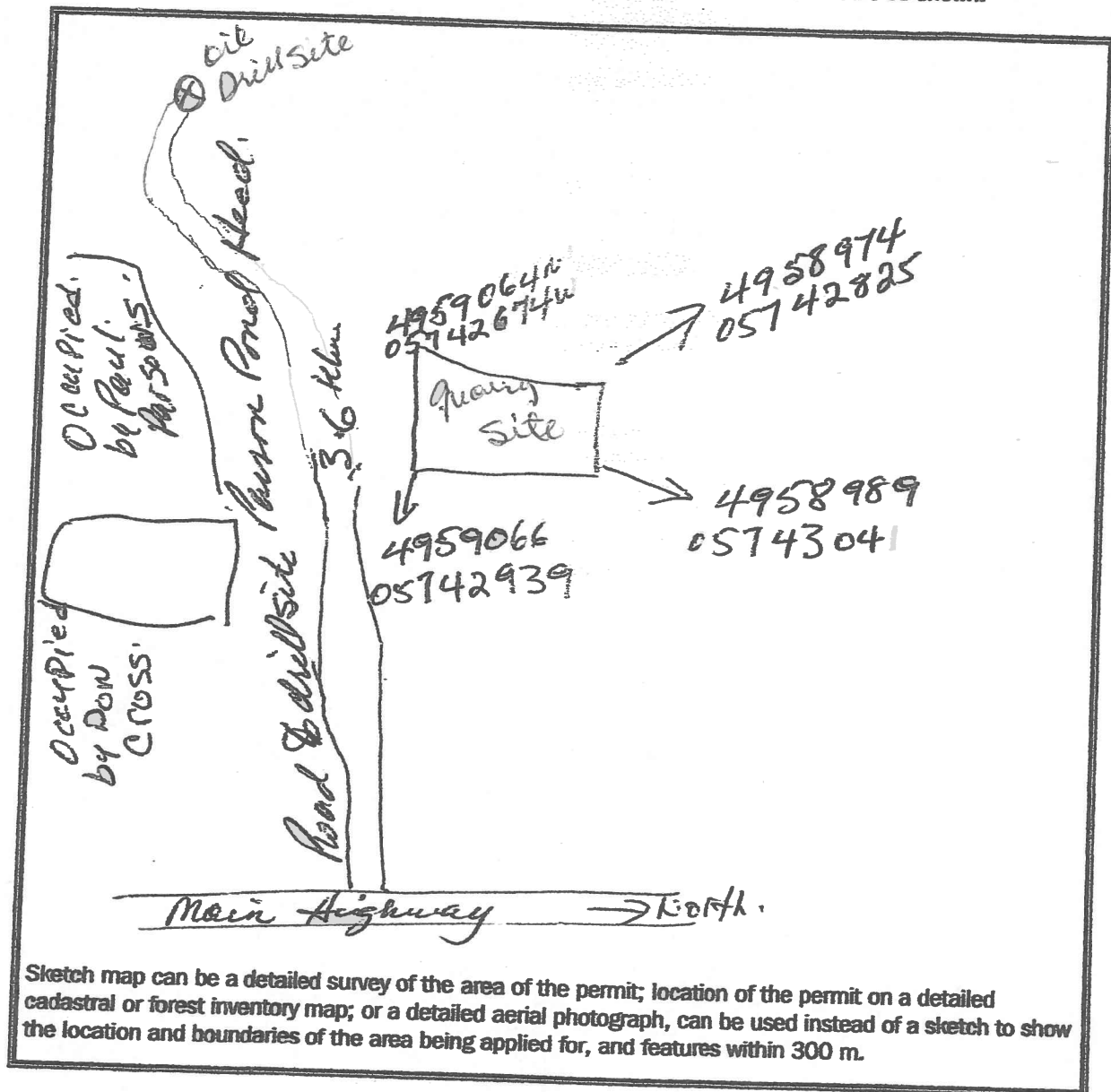

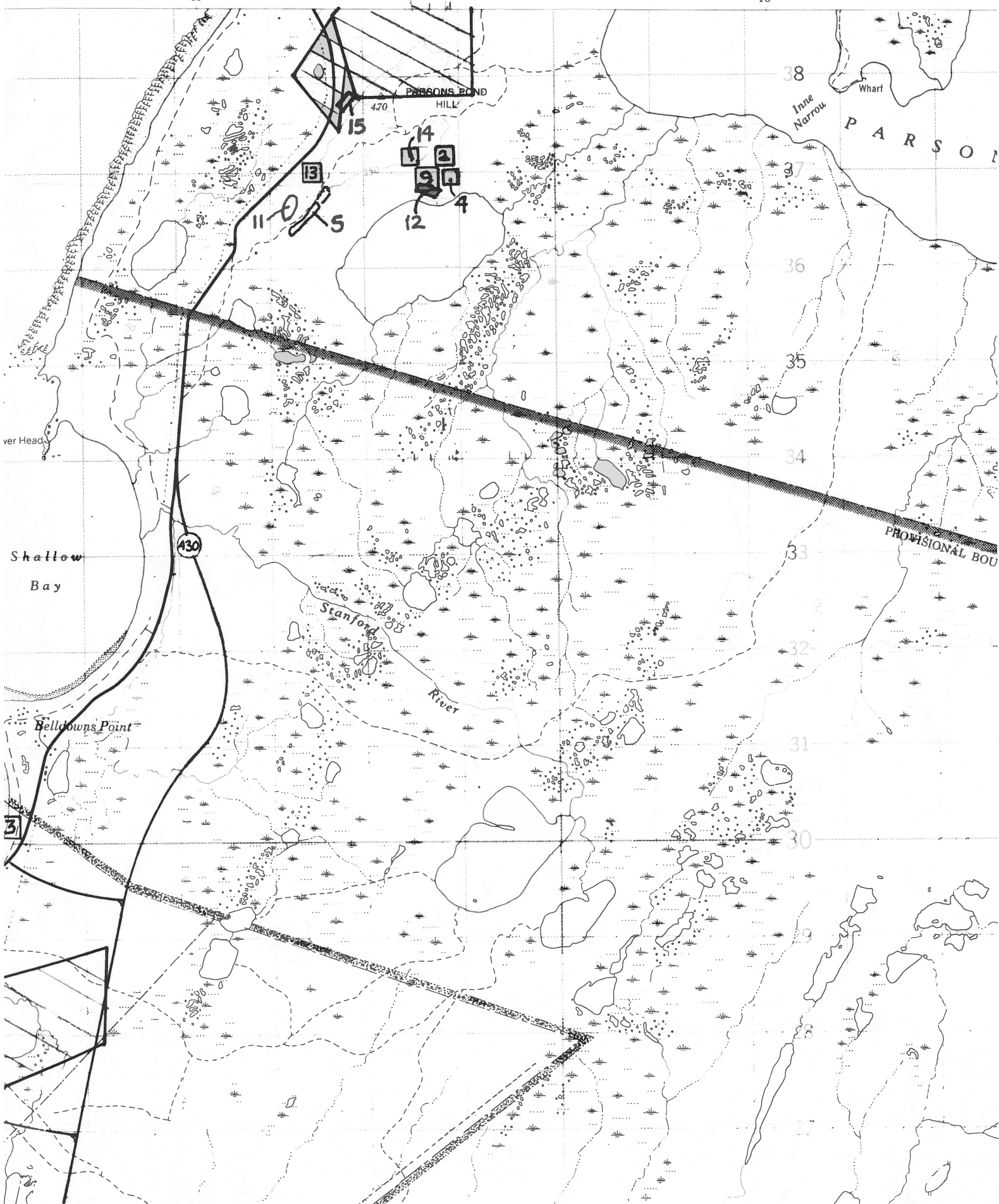
