Aggregate Quarry (Sand and Gravel).

ii. Purpose of undertaking:

To source screened sand and gravel for supply to various customers in the vicinity including Gander.

Description of the Undertaking:

- i. Location: Proposed pit is off TCH at Butt's Pond in the same general area as pits already in use by other operators. (698400E 5411500N Zone 21 5513095 Lat 1577572 Long.
- ii. Pit Access: Pit Access is provided by a cabin access road and existing pit access road used by other operators.
