The low relief of the surrounding landscape in conjunction with the no harvest buffer zones will provide a measure of viewscape protection for the local cabin areas. The negligible amount of birch on CBPPL limits in this area is overmature and susceptible to blow down.</p> <p>The Birch Reserve is located on Crown limits – CBPPL has no input into any mitigation issues.</p> <p>The Home Pond operating area was approved in the previous Five Year Plan (this is a resubmission).</p> <p>No further action required.</p> |

Woodlands (CBPPL) is involved in two separate processes concerning the deferral of harvesting on CBPPL limits that overlap MFN traditional territory: certification to the Forest Stewardship Council (FSC) National Boreal Standard; and as a signatory to the Canadian Boreal Forest Agreement (CBFA).</p> <p>Under both processes there has been a temporary deferral of</p> |

CBPPL has agreed to defer harvesting in the complete overlap area until July 1, 2017, to allow time to work on this issue, and will reconsider extending the deferral at that time.</p> <p>CBPPL has met with Chief Misel Joe and Gregory Jeddore of MFN several times to try to reach a compromise between their position of a permanent deferral of harvesting and CBPPL’s need for access to its timber licence, particularly the spruce, in some parts of the overlap area. MFN has remained firm on their position.</p> <p>Currently there is a timber review process in Central NL, CBPPL hopes the timber allocation review will provide a potential solution acceptable to all parties.</p> |
